Summary of the discussion on all matters:

9 community members are in person at Rockdale gym. Temps were taken and certification questions were asked to all in attendance today. Technical difficulties. One parent came in after the meeting started.

Meeting started at 6:32. Went through board agenda items. Communication went out to the community. Consideration in July BOE meeting was to start in hybrid, but it got declined. Policy is tied to public comment. 6:39 public comment-Ms. Thomas (parent)-ISAT scores how will they test? Dr. Schrik states that there is consideration on how it will play out in the spring. Operating under guidance since past spring no test was taken. Ms. Sontag-Amezcu (parent)-waive device fee? Dr. Schrik still looking at fees, younger fees are not being assessed. Mrs. Stadler states that it is not been discussed. Mrs. Majerus (parent)-is this model direct instruction? What is the band and choir-Mrs. Majerus. Dr. Schrik states it will be an extra curricular. Will not look like the spring. We should be providing 2.5 hours of direct instruction and use standards, address gaps, and then 2.5 hours of independent work. Will teacher lesson be recorded? Mrs. Majerus (parent). Dr. Schrik stated that it will be recorded. We have to be careful with confidentiality. Google has the strongest agreement. Mrs. Getto (parent)- for IEP's and how to address student needs? Servicing students who attend remotely and those outplaced will be serviced with those outside districts. We will be flexible and we will satisfy minutes. Service in smaller groups. Case manager will discuss individual needs of students. Ms. Guidera (parent)-will it be recorded? Dr. Schrik yes it will be recorded. We have to let the virus drive the virus. Is the end goal to get back to school? Dr. Schrik shared that Joliet 86 is going full remote. No way we can make this work without the help of the parents. Dr. Schrik. We have to be flexible. We need the parent cooperation. We have expectations. The plan is to go back to learning.



It will go from remote learning to hybrid and then to full in person learning. Re-assessing to 6-9 weeks. The state will give us guidance. Phase 4 of restore Illinois. Need to be in phase 5 as similar prior to COVID-19. Ms. Vlaicevic (guardian)- commenting on how she was able to stay at home and it was very difficult. The staff did their very best. Pre-recorded message and his education is important. At the end of each day, she felt like a failure. More hands on from teachers and need him to be on the computer. Very frustrated and wants the school. Mrs. Foster (parent)- appreciates Rockdale school and BOE. Layout what the school day. Dr. Schrik states there will be a schedule. In a stay at home order, we are not at a stay at home order. Working on logistics for grade levels. Submit it to teachers in spring did not work well from staff. Packets will be worked on. Will there be a syllabus. Dr. Schrik stated that teachers will be working with families. Information will be rolled out. Ms. Lurvey (parent)- focus on K-3. They missed out on CORE learning. How will they fill the gaps. Hands on to engage. Dr. Schrik not changing the direction. We will start with assessment and will be done in conjunction with implementing the curriculum. It is a concern and it will be important to learn school first especially social norms. Each student will receive a device? Ms. Johnson (parent)- had answers asked. Mr. Guidera (parent)-asked just for attendance. Not going to work. Parents will work 9-5. We will be flexible. Dr. Schrik states that we need to present. We will work through glitches. Find a way to work with in guidelines. Mrs. Majerus (parent)- if a majority of parents decide to homeschool at what point the district would be hurting? Dr. Schrik states, Homeschooling that you are separating from the district it has to be registered at ROE. Dr. Schrik states that enrollment is based on numbers. State funding will be lost by the district. It is a concern for Rockdale and the ROE. The number is hard to tell, but 10-25%. There is some federal relief. Ms. Lambert (parent)-are we allowing student teachers. Dr. Schrik- we partner with universities. No requests. Ms. Thomas has a question, but it was asked. Ms. Guzman (parent)- for the hybrid will we have another meeting so everyone is up to date?! Dr. Schrik states that we will have a meeting. It will be discussed. This is last chance to ask a question. The board will take into consideration and vote with the plan. No further questions. Mr. Chamblee-read the document. No further comments and is in agreement with the proposal. Mrs. Chamblee is good. Mrs. Wyke has no comments. Mr. Aich has no questions. Ms. Gordon wants to thank the questions from the in person community and virtually. Mrs. Stadler addresses the community. 7:56 pm the meeting adjourned.
