- C. Offer flexible meetings, such as meetings in the morning or evening, and provide, with funds provided under this part, transportation, child care, or home visits, as such services related to Parent and Family Engagement.
 - Title I meetings throughout the year will be offered at different times based on family survey results.
 - Title I meetings will accommodate families with small children and offer activity centers for children in attendance at the parent meeting.
 - When home visits are determined to be necessary, Family Engagement Coordinator (FEC) will contact the family to set up necessary arrangements.
 - When transportation is determined to be necessary FEC will assist the family in making arrangements to attend the event.

- PTO meeting where Parents, Teachers, and Students work collaboratively to plan and organize events and activities.

 - The FACE team principal and teachers will be a part of the committee of individuals who work together throughout the school year to plan review and improve the school improvement plan.

 - The FEC will provide monthly calendars/newsletters sent home with every student and posted on the county website.
 - The FEC will keep families informed of upcoming events, workshops and parent meetings by sending information letters as well as the reminders in a timely manner.
 - The FEC will maintain a Family Engagement Facebook page to provide parents with information regarding all upcoming events/workshop/informational meetings.
 - At the annual Title 1 meeting we will provide families with information on all curriculum used in classrooms as well as in Title I.
 - At the Annual Title I meeting we will introduce families to academic assessments used throughout the school year to measure student progress such as: SOLs, PALs. Benchmarks, etc.
 - The Title I Assessment meeting, SOL meeting, as well as Parent/Teacher Conferences will be offered throughout the school year to provide parents with information on a child's proficiency levels.
 - Families will be encouraged to contact teachers, as well as Title I teachers, of any concerns they have throughout the year in regards to their students' progress. They can also contact the Family Engagement Coordinator to help setup a time for a meeting between the teacher and parent.
 - Teachers will be available and flexible to accommodate all families.

 - FE will provide assessment meetings (PALs, SOLs, etc.) to help families understand assessment reports and monitor student progress.

 - FEC will offer annual family trainings to address literacy, technology, assessments, and others as
 determined through academic data and parent surveys.
 - FEC will offer (APTT) Academic Teacher Team Meetings with Kindergarten parents to help with grade specific skills meeting once every 9 weeks. In the Spring a SOL meeting for 3rd and 4th grade parents.
- 3) Provide professional development to teachers, specialized instructional personnel, and other staff on the value of parent and their communities to increase academic achievement.
 - Professional development opportunities will be offered based on the data in the comprehensive needs assessment.
- 4) Coordinate and integrate parent engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parent engagement.

- Wise County Schools will work collaboratively with the local head Start Program including tours of the schools and registration.
- Wise County Schools will operate a division-wide preschool program for at risk four-year old children.
- All parents of preschool children will be required to sign a parental engagement compact in which they agree to be involved in the educational process of their children.
- Each Title I school will be required to develop Family Meeting activities.
- Wise County Schools will operate a Family Resource Center within each school that receives Title I Part A funds.
- Each FEC will offer a Story Time at the schools once a month for families with children Birth-4 years old.
- Each FEC will offer Learning Club twice a month to children that are on the Pre-K waiting list and those that will begin Kindergarten the following year.
- The Family Resource Center will be staffed during the school year at a minimum of 20% of the school day and up to a maximum of 50% of the school day. The Family Resource Centers will have some flexible hours to accommodate various parent work schedules as necessary at each school.
- The center staff will provide technical assistance for parents in obtaining curriculum information, information regarding the local and state assessment program, and all available services provided by the school division.
- 5) Ensure that information related to school and parent programs, meetings, and other activities is sent to the parents of participating children in a format and, to the extent practicable, in a language the parents can understand. (List actions)
 - The FEC will provide monthly calendars/newsletters sent home with every Title I student and posted on the county website each month.
 - The FEC will keep families informed of upcoming events by sending informational letters as well as reminders in a timely manner.
 - ESL families will be provided with documentation in their home language when necessary.

 - FEC will hold meetings with faculty and staff to highlight model approaches to improve Parent and Family Engagement.
 - FEC will attend annual training on Family Engagement
 - FEC will meet monthly to discuss and share best Family Engagement practices.
- 8) May pay reasonable and necessary expenses associated with local Parent and Family Engagement activities, including transportation and childcare costs, to enable parents to participate in school-related meetings and training sessions.

- The District Title I Advisory Council will meet twice a year to discuss Title I programs/budget, Parent and Family Engagement, and other topics as necessary.
- 9) May train parents to enhance the involvement of other parents.
 - Yearly collaboration meetings will be held with FEC, local organizations, VPI leaders, and community stakeholders to better Family Engagement in the county.
