**MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE
INYO COUNTY OFFICE OF EDUCATION AND
BISHOP UNIFIED SCHOOL DISTRICT
regarding Information Technology Service**

This MOU, made and entered into on the 1st day of July 2019, by and between INYO COUNTY OFFICE OF EDUCATION, hereinafter referred to as the **COE**, and the BISHOP UNIFIED SCHOOL DISTRICT, hereinafter referred to as the **DISTRICT**.

The **COE** hereby agrees to furnish Information Technology Service to the **DISTRICT** for the period beginning July 1, 2020, and ending June 30, 2021.

This MOU is to address additional technology support required to address increased technology needs by the district to support student learning and teaching support due to the COVID-19 pandemic.

COE RESPONSIBILITIES:

- Provide additional Information Technology Service from July 1st, 2020 through December 30, 2020 to Support the following **DISTRICT** needs:
 - o Support for New and added 1-to-1 Student devices
 - o Remote and in-person distance learning technical support for Students and Staff
 - o Support Student Device Hotspot for Distance Learning

DISTRICT RESPONSIBILITIES:

- Reimbursement to COE for additional service

COMPENSATION FOR SERVICES:

Charges for the services requested above and during the term of this MOU shall be:

2020/2021 Fiscal Year \$ 35,000

Additional services during the term of this MOU shall only be provided upon the written consent of both parties.





Invoices shall be sent by the **COE** to the **DISTRICT** by **January 31st** for services provided.

RIGHT TO TERMINATE AGREEMENT:

This MOU may be terminated by either party upon receipt of written notification sixty (60) days prior to the contract ending date. Prior termination must be mutually agreed to due to budget ramifications.

This MOU constitutes the entire agreement of the parties and any prior or contemporaneous representations or statements are completely merged herein. This agreement may be amended in writing by the mutual consent of the parties hereto.
