028-19 APPROVAL OF MINUTES

It was moved by Ms. Oyer, seconded by Mr. Szoke to approve the minutes of the organizational and regular meeting from January 9, 2019. On roll call, the vote was as follows: Ayes – Ms. Oyer, Mr. Hobbs, Mr. Boyer, and Mr. Szoke. Motion carried.

LEGISLATIVE UPDATE

Mr. Hobbs spoke of two recent bills; one regarding graduation requirements and the other state control of school districts concerning academic performance. Ms. Zaler updated the Board with the Cupp/Patterson school funding workgroup's progress, projected timeline regarding release of detailed information, and the upcoming State Legislative Conference on March 19, 2019. Ms. Zaler will be reaching out to Representative Wilkin for a time to speak with him and encourage his support of the new school funding model. Mr. Hobbs noted that we had been asked to show support of the new gas tax as well and how the school district would benefit and save money.

STUDENT/STAFF RECOGNITION

Mr. Boyer praised the students and staff for the production of the musical, Adams Family, noting there was a packed house every night.

GENERAL DISCUSSION WITH POSSIBLE APPROVAL

Mr. Dickens presented the 2019 Federal Poverty Guidelines for approval to set preschool tuition rates.

029-19 APPROVAL OF 2018 FEDERAL POVERTY GUIDELINES

Mr. Hobbs moved with Mr. Szoke seconding the motion to approve the 2019 Federal Poverty Guidelines as presented by Superintendent Dickens. On roll call, the vote was as follows: Ayes – Ms. Oyer, Mr. Hobbs, Mr. Boyer, and Mr. Szoke. Motion carried.

Mr. Dickens also noted that with all the snow days the staff in-service day scheduled for March was being moved to the end of the school year making the last day for students May 29, 2019.

Zach Dixon, new Chief of Police for the Village of Waverly met with Mr. Dickens and noted that such a formal agreement was not needed.
