Update on Ridgefield Remote

Dr. McCann presented an update on the planning process to re-open schools in a distance only model, moving toward a hybrid model for the 2020-2021 school year. Dr. McCann provided some background on Ridgefield Remote. Angie Gaub, principal at Union Ridge Elementary presented the plan and schedules for grades K-6 and Tony Smith, Principal at View Ridge Middle School presented the plan and schedules for grades 7-12. There was a lengthy discussion and many questions from the audience were addressed.

Director Emily Enquist thanked everyone for all of the hard work that went into planning for Ridgefield Remote and for the 2020-2021 school year. Director Brett Jones echoed Director Enquist's comments and expressed appreciation for the presentation of the information.
