Community Eligibility Provision (CEP)—Year 3 and Successive Years

The Pawnee Independent School District announced today it will continue its policy to operate the Community Eligibility Program (CEP) under the National School Lunch Program and School Breakfast Program for the 2020-2021 school year at the Pawnee ISD sites where it currently provides meal service. Schools qualifying to operate CEP serve breakfast and lunch to all children at no charge and eliminate the collection of meal applications for free, reduced-price, and paid student meals. This new approach reduces burdens for both families and school administrators and helps ensure that students receive nutritious meals.

Pawnee ISD is required to collect and report the socioeconomic status of each student to the Texas Education Agency for the purpose of the annual state accountability ratings and for federal reporting. Please complete the Socioeconomic Information Form and return to school as soon as possible.
