## Kindergarten Health Requirements 2020-2021 School Year

Dear Parent/Guardian,

Your child will be entering Kindergarten in August of 2020. **The State of Illinois requires all incoming Kindergarten students to have a current Illinois physical exam and up to date immunizations, vision exam and dental exam for entrance into Kindergarten.**

The state requirements for 2020-2021 school year are as follows:

**Physical Exam must have the following completed: Due Oct. 15th, 2020**

- A current State of Illinois Certificate of Health Exam form (attached) done within the past 365 days prior to the first day of school- no other form will be accepted
- Physical exam must be completed, signed, and dated by a doctor
- Immunization Record must be up to date and in compliance with IL Dept. of Public Health. Please check with your child's Dr. to make sure they are up to date for entrance into Kindergarten. Most children entering Kindergarten will need a DPT, Polio, MMR, and Varicella immunization
- Parents need to complete, sign and date the health history on the backside top portion of the physical exam form

**Eye Exam must have the following completed: Due Oct. 15th, 2020**

- Illinois Eye Exam Report Form (attached)- no other form will be accepted. The eye exam may be no more than one year old (365 days) prior to the first day of school and must be done by a licensed physician who can do eye exams or an optometrist. If you need assistance finding an optometrist, please call the school nurse
- Eye Exam Waiver Form (attached) if unable to obtain an eye exam

**Dental Exam must have one of the following completed: Due May 15th, 2021**

- IL Dept. of Public Health Dental Exam Form (attached)- no other form will be accepted
- If your child has had a dental exam, the exam must be **after** November 15th, 2019 to meet the Kindergarten requirement

A completed physical exam and up to date immunizations must be turned into the school by **October 15th, 2020**.
