Minutes

- 1. Call to Order:** Ricky Emerson called the meeting to order at 5:30pm and verified a quorum of board members were present in the zoom meeting. Those in attendance were Mrs. Emerson, Heather Muir, Joel McMahan, Darla Mullins, Sandra Freitas, Dr. Paul Farris and Nancy Nebeker. Angela Bowen was unable to attend.
- 2. Teaching and Learning in the 2020-2021 School Year:** Dr. Farris explained that Chris Reykdal, Washington State Superintendent of Schools, is hopeful that schools will open as normal in the fall of 2020. However, he has also requested districts present reopening plans in preparation for potential changes. Dr. Farris said that our district's survey of staff, students, families, and the community is almost complete. He is putting together a core planning team who will use the resulting data as well as collaboration with OSPI and the Department of Health to create the plan for our fall return to school.

3. **Executive Session:** Mrs. Emerson read the White Pass School District Mission Statement and announced the board will enter executive session at 5:36 for 35 minutes to evaluate the qualifications of an applicant for public employment or to review the performance of a public employee RCW 42.30 110 (1g). 5. **Adjournment:** Mr. McMahan made a motion to adjourn. Mrs. Muir seconded. The motion passed unanimously, (5, 0). The meeting adjourned at 6:37pm.
