Dear Parents:

Riverside USD 114 board policy allows students who reside outside of USD 114 boundaries to attend district schools. Below are guidelines for accepting Out of District students.

- 1. Out of district students will be accepted on a space-available basis as determined by district and state guidelines with building principal and superintendent approval. All applicants will be notified as soon as possible regarding their acceptance to attend USD 114.
- **2.** Out of state tuition will be charged for any <u>new out of state</u> student. The tuition for 2023-2024 will be \$2544 per student or \$1272 per semester. All students will be charged full price for textbook rental and student fees. All tuition and fees are to be paid at the time of enrollment or at least one day prior to attending school. NO EXCEPTIONS. Proof of residency may be requested of former out of district students that provide an in district address.
- 3. Payment plans or waivers of fees are not allowed for out-of-district students.
- **4.** Riverside USD #114 must have all school records, IEP, transcript, attendance, and discipline documents from your previous school before attending. An out of district student who is under suspension or expulsion from another district for disciplinary reasons will not be accepted. Contact will be made with the previous school to verify the information provided is accurate. Misrepresentation of information will result in the request being denied.
- 5. Please return out of district requests to the appropriate building office.
- **6.** As long as the out of district student remains in good standing they will automatically be approved annually. USD 114 Riverside will communicate in writing to any student stating that attendance privileges have been revoked.

To remain in good standing out of district students must:

- Minimize absences and maintain good school attendance. (Less than 9 absences excused/unexcused)
- Demonstrate a commitment to academics. (Maintain no failing grades)
- Demonstrate good behavior. Repeated disciplinary referrals will result in having attendance privileges revoked. (6-12th grade students should have less than nine accumulated points and no suspensions)

Any student that does not remain in good standing will have their attendance privileges revoked at the semester. (Exceptions will only be granted by the district superintendent.) Parents and students must realize that enrollment is a privilege, and Riverside USD #114 is not obligated by law to provide an education for out of district students.

Please sign to verify that all information listed on the application is accurate and that you understand the guidelines for out of district enrollment in USD 114.
