Motion by K. Jansky and seconded by A. Erdkamp to verify that this meeting of the School Board of Exeter-Milligan Public Schools was duly advertised and that all board members were notified as to the time and place of the meeting pursuant to board policy and practice. Motion carried 6-0.

Motion by T. Pribyl and seconded by K. Oldehoeft to approve the consensus agenda consisting of the treasurer's report, the minutes from the regular board meeting on August 15, 2018 and the September expenditures. Motion carried 6-0.

Curricular Report

Superintendent Sheffield presented the 2018-2019 junior high and high school class schedule to the board and discussed the changes that have been made for this year.

Old Business

Superintendent Sheffield gave the board an update regarding the completion of the concrete project which added additional angle parking and a drop off area on East Boundary. The street work on East Boundary has also been completed. New fencing has been installed at the east end of the playground area and a separate fence has been installed for the pre-school playground. There may be an additional gate added to the fence for convenience purposes.

The negotiations committee will plan to meet with representatives from the Exeter-Milligan Education Association after next month's regular board meeting in order to start working on the 2019-2020 negotiated agreement for the district's certificated staff.

New Business

Motion by E. Milton and seconded by A. Erdkamp to adopt the 2018-2019 Budget of Expenditures as published in the August 29, 2018 Nebraska Signal. Motion carried 6-0.

Motion by K. Oldehoeft and seconded by K. Jansky to notify the Fillmore County Board of Equalization of the following property tax requests for the Exeter-Milligan Public School District #30-0001: General Fund request of \$3,805,015.04 and a Special Building Fund request of \$505,050.50 for a total tax request of \$4,310,065.54 as published in the August 29, 2018 Nebraska Signal. Motion carried 6-0.

Motion by T. Pribyl and seconded by K. Jansky to approve Superintendent Sheffield as the district representative for all local, state and federal programs. Motion carried 6-0.

Information/Discussion

The NASB State Convention will be held in Omaha from Wednesday November 14th to Friday November 16th. Board members need to inform Superintendent Sheffield if they plan on attending the conference.

Superintendent Sheffield discussed the NASB Regional Training Meeting for board members being held in York Wednesday September 19th at 5:00 pm. Several board members plan on attending the event.

A film crew will be at the school and other places in the district in order to collect video footage for a commercial they are producing that highlights the newly formed football cooperative agreement between our district and Friend Public Schools.

The next regularly scheduled board meeting will be October 10, 2018 at 8:00 pm in the band room at the Milligan site.

Motion by T. Pribyl and seconded by E. Milton to adjourn the meeting at 8:42 pm. Motion carried 6-0.
