President S. Kuska declared the regular meeting open at 3:41 pm. Those present were S. Kuska, T. Pribyl, E. Milton, K. Jansky, K. Oldehoeft, A. Erdkamp, Superintendent Sheffield and Principal Kroll. There were eight visitors present. The Nebraska Open Meetings Act was posted.

Motion by K. Jansky and seconded by A. Erdkamp to verify that this meeting of the School Board of Exeter-Milligan Public Schools was duly advertised and that all board members were notified as to the time and place of the meeting pursuant to board policy and practice. Motion carried 6-0.

Motion by K. Oldehoeft and seconded by T. Pribyl to approve the consensus agenda consisting of the treasurer's report, the minutes from the regular board meeting on August 8, 2017 and the September expenditures. Motion carried 6-0.

#### Old Business

Superintendent Sheffield gave the board an update regarding the locker room and hallway remodel project. The exterior doors and locker units have been installed in both sets of locker rooms. Drainage issues have been discovered in one of the locker rooms that will be fixed. We are still waiting for individual shower doors for both locker room areas. The doors have been re-ordered due to a manufacturing error. A few minor craftsmanship issues still need to be addressed by the contractor.

The board discussed the different options available to the district for our high school football program next year. Superintendent Sheffield and Mr. Filipi plan to attend a Nebraska School Activities Association football meeting scheduled on September 20, 2017. Enrollment calculations for all school districts competing in football will be completed on September 30, 2017.

#### New Business

Motion by K. Jansky and seconded by E. Milton to adopt the 2017-2018 Budget of Expenditures as published in the September 6, 2017 Nebraska Signal. Motion carried 6-0.

Motion by T. Pribyl and seconded by K. Oldehoeft to notify the Fillmore County Board of Equalization of the following property tax requests for the Exeter-Milligan Public School District #30-0001: General Fund request of \$3,849,215.85 and a Special Building Fund request of \$454,545.45 for a total tax request of \$4,303,761.31 as published in the September 6, 2017 Nebraska Signal. Motion carried 6-0.

Motion by A. Erdkamp and seconded by K. Jansky to approve Superintendent Sheffield as the district representative for all local, state and federal programs. Motion carried 6-0.

A letter sent by Nebraska State Senator Rick Kolowski to all district School Board Chairpersons and Superintendents asking for input regarding the formation of a legislative platform for future educational needs in the State of Nebraska was discussed by the board.

#### Information/Discussion

The NASB State Convention will be held in Omaha from Wednesday November 15<sup>th</sup> to Friday November 17<sup>th</sup>. Board members need to inform Superintendent Sheffield by Wednesday September 20, 2017 if they plan on attending the conference.

Superintendent Sheffield discussed the NASB Regional Training Meeting for board members being held in York September 13<sup>th</sup> at 5:00pm.

The Purple Ribbon Meat Program has organized a Pigskin Raffle to be held during the Exeter-Milligan vs. Friend football game scheduled for 7:00 pm September 22, 2017. Winning tickets will be drawn at the beginning of each quarter. Winning ticket holders receive a half of a hog donated to the program. Raffle proceeds will be used to offset ongoing program costs.

Motion by T. Pribyl and seconded by K. Jansky to go into Executive Session at 4:28 pm to discuss possible litigation involving the district. Motion carried 6-0.

Motion by A. Erdkamp and seconded by K. Jansky to return from Executive Session at 4:38 pm. Motion carried 6-0.

The next regularly scheduled board meeting will be October 11, 2017 at 8:00 pm in the band room at the Milligan site.

Motion by K. Jansky and seconded by K. Oldehoeft to adjourn the meeting at 4:42 pm. Motion carried 6-0.
