Old Business

Superintendent Sheffield gave an update on the building project. There are a few tile and paint repairs to be completed. We are waiting on some siding, signage, and glass for the trophy cases.

There will be some landscaping (including new concrete) around the locker room outside doors.

We will also continue to work on the drainage on the east side of the school.

New Business

Motion by K. Jansky and seconded by A. Erdkamp to adopt the 2016-2017 Budget of Expenditures as published in the September 7, 2016 Nebraska Signal. Motion carried 4-0.

Motion by A. Erdkamp and seconded by K. Jansky to notify the Fillmore County Board of Equalization of the following property tax requests for Exeter-Milligan Public School #30-0001. General Fund - \$4,020,631.64 and Special Building fund - \$621,212.12 for a total tax request of \$4,641,843.76 as published in the September 6, 2016 Nebraska Signal. Motion carried 4-0.

Motion by A. Gloystein and seconded by K. Jansky to approve Superintendent Paul Sheffield as the representative for all local, state, and federal programs. Motion carried 4-0.

There has been a suggestion to install underground sprinklers at the Milligan football field. This will be tabled until more information is obtained from the Village of Milligan and the Milligan Community Club.
