Motion by T. Pribyl and seconded by A. Erdkamp to verify that this meeting of the school board of Exeter-Milligan Public School was duly advertised and that all board members were notified as to the time and place of the meeting pursuant to board policy and practice. Motion carried 6-0.

The board members took the Oath of Office and filled out the Conflict of Interest Declarations. Officers elected for 2015 elected: President - Sharon Kuska; Vice President - Tim Pribyl; Secretary - Annette Gloystein; Treasurer - Jim Zeleny

Motion by A. Erdkamp and seconded by T. Pribyl to approve the consensus agenda consisting of the treasurer's report, the minutes of the December 15, 2014 regular meeting, and the January expenditures. Motion carried 6-0.

Curricular Report

Principal L. Schlueter reported on the Work Release program. One student participated during the 1st semester. Two students will participate during 2nd semester. Principal Schlueter and Guidance Counselor Tim Wilbeck make regular visits with the students at the work site during work hours. The students are required to document their work experiences weekly and provide copies of their pay stubs. Mr. Schlueter believes the program is going very well.

Motion by T. Pribyl and seconded by A. Erdkamp to designate KSB School Law as the law firm authorized to provide the school district with legal counsel. Motion carried 6-0.

Annette Gloystein was appointed as a new member of the Exeter-Milligan School Foundation.
