Motion by T. Pribyl and seconded by J. Zeleny to approve the consensus agenda consisting of the treasurer's report, the minutes of the July 16, 2014 Student Fees and Parental Involvement Hearings, the July 16, 2014 regular board meeting, and the August expenditures. Motion carried 5-0.

Old Business

Buildings and Grounds Update: Outdoor lighting has been repaired (storm damage). The elementary windows are repaired but the high school and shop windows have not arrived yet (storm damage). Carpet replacement is complete (storm damage). A decision on repairing or replacing the roofs at the Exeter site will need to be made (storm damage).

The track field events upgrade project cement work and grass seeding are complete and the rubber overlay is scheduled to be done in September. The Exeter site music room air conditioner needed to be replaced. Furnace work at the Milligan site gym has been started. The fence for the north edge of the preschool playground has yet to be installed and there will be some more concrete work done at the location. There was some discussion on doing some modifications on the fence around the Exeter site football field/track.

The board received information on the 2014-2015 Budget. There will be a budget workshop on Monday, August 25, 2014 at Milligan.

There is an enrollment of 14 students in the newly established Preschool/TYKE program at the Exeter site.

Motion by B. Moore and seconded by T. Pribyl to approve the one-year agreement with Friend Public School to co-op junior high football. Motion carried 5-0.

New Business

Motion by J. Zeleny and seconded by B. Moore to approve Tara Milton as a local substitute. Motion carried 5-0.

A Budget Work session is planned for Monday, August 25, 2014 at 8 PM in Milligan. The only action item will be a transfer from the general fund to the depreciation fund.

The Budget Workshop will be on Monday, August 25, 2014 in Milligan at 8:00 PM.

The FCDC (Fillmore County Development Corporation) has invited Exeter-Milligan Public School to join the organization. The board believed this would be acceptable and directed Superintendent Sheffield to take care of joining.

The next regular meeting will be on Wednesday, September 10, 2014 in Exeter. The Budget Hearing will begin at 8:00 PM followed by the levy hearing with the regular meeting to follow the two hearings.
