## Old Business

The Buildings and Grounds Committee met and gave an update on possible remodeling or building projects. The committee will have more information to present at the January 15, 2014 regular meeting.

Superintendent Sheffield presented the board information on the possible Separation Incentive Program. The board will discuss this in January.
