Dear Households:

As families are readying for the new school year, which is quickly approaching, the food service department at Robinson Cafeteria is also preparing to provide healthy, nutritious meals for our students and staff!

Marfa Independent School District would like to announce that all children enrolled in the District for the 2020-2021SY will be provided breakfast and lunch **free of charge**.

Changes:

- No snack bar until further notice.
- No strawberry milk until further notice (chocolate/white only).
- Every student eats free meals (breakfast *and now lunch!*)
- Socially distanced cafeteria.
- No microwaves for students in diner until further notice. Students are asked to bring food in a thermos for hot/cold holding.
- Parents/Guardians will not be able to bring food from home and drop it off at the cafeteria. Student must bring their home lunch with them when they come to school.

**!!!!MEALS SERVED WILL BE HOT MEALS!!!!**

Here is what parents/guardians need to know for the first week of school meal service (4 days):

- For the 1<sup>st</sup> week of school (first 4 days of virtual school) both breakfast and lunch will be provided at the same time.
- Parent pick up is allowed (children need not be present with parent for meal pick up).
- Pick up time will be from 10A to 12:30P (first 4 days of virtual school only!).
- Pick up will be in front of Robinson Cafeteria (drive up, no need to get off your vehicle).

**PLEASE NOTE: YOUR CHILD MUST BE COUNTED AS PRESENT AT SCHOOL (EVEN VIRTUAL SCHOOL) IN ORDER TO RECEIVE A FREE MEAL.** \* If a student takes a meal and they were absent on the day they took the meal, the meal taken will be charged to the student's meal account. \*

Here is what parents/guardians need to know for the second week of school meal service and thereafter:

- For the 2<sup>nd</sup> week of school and thereafter, methods of meal service:
  - Meals provided in the classroom.
  - Meals provided in the cafeteria (socially distanced for in-cafeteria dining).
  - Meal pick up in front of the cafeteria

**PLEASE NOTE: MEAL PICK TIME FOR 2<sup>ND</sup> WEEK OF SCHOOL AND THEREAFTER: 10A to 11:00A ONLY!**
