Municipal Tree Planting -Permits and Violations -

- Mr. Khan of 5 Timber Grove requested removal of 3 trees after D.C and G.L surveyed the property it was learned that two of the trees occupancy is on conservation easement. Mr Kahn was instructed to come to the meeting to state his case to the Commissioners.
- Sodino Contracting was in violation and fined \$250 for not having a permit and another \$250 for removing a Heritage Tree. Also required to plant 5 trees.
