# Minutes of the School Board Meeting School District of Shullsburg August 12, 2020

The meeting was called to order at 6:30 p.m. by President, Eugene Uehling.

Motion by L. Gill, seconded by C. Teasdale to declare the meeting a legal meeting. All voted yes, and the motion was adopted.

Mr. Lierman reported that the in-person graduation ceremony was held on Friday, August 7<sup>th</sup> in Badger Park and everything went very good.

### Administrative Reports

A. Principal's Report

Mrs. Bendorf gave updates on Apptegy and Summer School. 241 people have downloaded the app and our summer enrichment program had 4, 560 ½ hours for 5 ½ FTE.

#### B. District Administrator's Report

Mr. Lierman gave an update on summer maintenance progress, interviewing of candidates for open positions, HS Football and JH fall sports. Maintenance is working on finishing floors, making classroom dividers, the paper towel dispensers on back order. We are currently interviewing candidates for the long term substitute and custodian positions. HS Football – the Illinois students are not allowed to play football in the fall in Wisconsin. JH Fall Sports – junior high football will be moved to the spring and JH Volleyball the Athletic Directors are working on a schedule with just the Wisconsin schools. The Illinois schools are not allowed to play in the fall.

Motion by L. Gill, seconded by L. Ray to approve the 4 alternative applications for open enrollment out of the Shullsburg School District. On a roll call vote, all voted yes and the motion was adopted.

Motion by L. Gill, seconded by M. Andrews to not allow the Benton bus to pick up a resident student in the Shullsburg School District. On a roll call vote, all voted yes and the motion was adopted.

Motion by L. Ray, seconded by L. Gill to approve Policy 2266 – Nondiscrimination of the basis of sex in education programs or activities. On a roll call vote, all voted yes and the motion was adopted.

Motion by C. Teasdale, seconded by M. Andrews to approve adjourning to closed session at 6:54pm. On a roll call vote, all voted yes and the motion was adopted.
