# Booneville School District School Board Meeting Minutes February 14, 2023

The Booneville School Board met at 6:00 P.M. in the conference room of the Administrative building on Wednesday February 14, 2023 for the regular February board meeting.

In attendance were: Dustin Garrett, Presiding Officer; Mark Wooldridge, Eric Jones, Todd Tatum, Bobby Haynes, Clay Crowley, Amy Daniel and Superintendent Trent Goff.

Mr. Walker informed the board that Junior Beta was well represented at this year's Beta Convention and he introduced Sara Lee who is the Junior Beta Sponsor. Junior Beta members in attendance were Lily Haynes, Lucy Haynes and Kaci Aydelott. Mr. Walker stated there were 50 out of 70 Booneville Junior Beta members in attendance at this year's Beta Convention. He listed the criteria to be a Beta member and that the Beta convention is by invitation only. Mr. Walker congratulated the club members' abilities and achievements. Ms. Lee added that Junior Beta has been in existence for 12 years and stated the four pillars of achievement as a Beta Club member. Mr. Walker reported for Mrs. Goers, who was unable to attend. He said the high school just kicked off their new reading assessment program called DreamBox (10th-12th) that is prescriptive for the level of the students who are using it.

Mrs. Haynes reported that the Pre K enrollment is currently at 98 and relayed that the PreK was recently awarded \$105,000.00 from the American Rescue Plan Act (ARPA) and that it will help sustain the current program.

A motion was made by Todd Tatum and seconded by Amy Daniel to approve the purchase of the in-person instruction coaching Professional Development service from Solution Tree (Tips/Taps) in the amount of \$137,800.00 using School Improvement funding that will be utilized at the Elementary and Junior High. Motion carried with unanimous consent.

### SUPERINTENDENT'S REPORT

Mr. Goff reported that there is a School Safety Funds Grant that will be applied for once priorities have been met.

Mr. Goff has learned that the same partners cannot apply for the JUA grant at the same place as the last grant was awarded, and that the district plans to apply next year for the JUA grant once the criteria is revealed.

Mr. Goff gave a brief overview of the latest legislative updates that he recently shared with the board. He added that Mr. Harvie Nichols is currently attending and maintaining contact with Mr. Goff on all of the education initiatives.
