RESOLUTION

WHEREAS, the Board of Education of Cedar County School District No. 14-0008, a/k/a Hartington-Newcastle Public Schools is obligated to pay ongoing expenses and increasing expenditures to operate the school district; and

WHEREAS, the Board has determined that it needs to collect more property taxes than it collected in the prior year; and

WHEREAS, on September 9, 2020, the Board published notice in a newspaper of general circulation; and

WHEREAS, said notice was published at least five days prior to the Board's special meeting; and

WHEREAS, said notice included the required items as specific in Neb. Rev. Stat. § 77-1601.02;

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of Cedar County School District No. 14-0008, a/k/a Hartington-Newcastle Public Schools, that the Board has considered and approved the property tax request for the following year, as follows:

- 1. The amount of the property tax request is \$5,214,887 for the General Fund and \$328,283 for the Special Building Fund, for a total request of \$5,543,170.
- 2. The total assessed value of property differs from last year's total assessed value by 1 percent;
- 3. The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property, would be \$.473567 per \$100 of assessed value;
- 4. The Hartington-Newcastle Public School District proposes to adopt a property tax request that will cause its tax rate to be \$.491347 per \$100 of assessed value;
- 5. Based on the proposed property tax request and changes in other revenue, the total operating budget of Hartington-Newcastle Public Schools will exceed last year's by -7 percent.
