President Haas explains that because this is a work session no action will be taken so comments will be closed, however he encourages the public to follow the process for submitting a comment/question for the 8/10/20 Board Meeting. Superintendent Tack explains that this has been a challenging and difficult process. That the health and safety of students, community and staff have been the number one priority. The task force has put in a lot of effort to come up with plan being proposed tonight. They have work through much feedback from community members, students, staff. They have gone through many publications from the state, and health departments trying to follow their guidance. We know that this can't look the same as it did in the spring. The focus has been on being able to provide a robust learning plan for each student. Tonight will be focusing on the teaching and learning side of our plan. Dr. Krager's letter to Cowlitz County Superintendents changed many things. In his letter he highly recommended remote learning.


At this time we are proposing that families have 2 options:

- 1. 2.0 Remote Learning with the possibility to pivot to hybrid/in person learning as safety permits.
- 2. Kelso Virtual Academy (KVA) Full online learning.

It is important that everyone knows we prefer to have students in person full time and will work to that as we are able.



### Decision Tree for Provision of in Person Learning among Public and Private K-12 Students during COVID-19




# Internet Accessibility and Support


- Teachers received a ½ day Google Classroom training in June

## **High School Grading Guidelines** .



Letter Grade Options: A, B, C, I

Teachers will issue grades of A, B, C, or Incomplete. Students cannot receive a P, NC, or F. The only exceptions to this rule are students who have learning plans that specify a specific grading system.

- · You will receive a traditional letter grade on your high school transcript.
- · Letter Grades continue to impact cumulative GPAs.



### Incomplete

Students who do not or cannot engage in learning may earn an Incomplete. Students who earn an Incomplete will have a wide variety of ways to complete a course.

- The incomplete remains on your transcript and can be changed to a letter grade when the course has been completed at some point during high school. There are several options for completion (such as retake course, test out, etc.). Please work with your high school counselor.
- · Incomplete grades do not impact cumulative
- GPAs positively or negatively.
- If you are maintaining NCAA eligibility, please check with the Clearinghouse about incompletes.
- Please research your post-secondary institutions (military, trades, apprenticeships, and 2- or 4-year institutions) about incompletes.

# **Elementary School Grading**



Numerical Grade Options: 1, 2, 3, 4

Teachers will issue grades of 1, 2, 3, or 4. The only exceptions to this rule are students who have learning plans that specify a specific grading system.

# —Middle School Grading Guidelines—



Letter Grade Options: A, B, C, I

Teachers will issue grades of A, B, C, or Incomplete. Students cannot receive a P, NC, or F. The only exceptions to this rule are students who have learning plans that specify a specific grading system.

Last spring the internet was an issue, we are working with outside providers to get the internet to every family. Money from the CARES Act will mean that the school can pay for internet for families who qualify. We have learned that most of our county have internet available (capability). There is just a small pocket in Rose Valley and we are working on finding a solution.

We will have only 1 platform for students to log into (Google). All other links will be provided here for students so there is no confusion about where to go when they log on.

Our goal with 2.0 this fall is to "knock it out of the park!" We are working our hardest to provide a high quality education during this uncertain time. We understand that in the Spring this is not where we were, but we have learned a lot since then.

We will have elementary parent teacher conferences before elementary students begin school. Our goal here is to get families familiar with their Chromebook, logged in, started up and to find out how we as a district can best support individual families. This will provide time to make a connection and find out what the specific needs are of everyone. We know each family will be unique. Teachers will be able to schedule families around the same time for those with multiple students in the same school.

The plan is to return old Chromebooks and get new models so that everyone has an updated device. In anticipation, we were able to get devices ordered early and are on track to get here in time to be set up and handed out. Teachers will also be getting Chromebooks so they will be working with the same system that students are. This will allow for 2 screens for each teacher as well, one for videoing and one for hands on teaching. Huge shout out to the tech department who has worked tirelessly to achieve this for everyone.

We are working diligently to get a comprehensive FAQ document for families to be able to troubleshoot.

Teachers will be onsite all day each day.

How will we get information to working parents if the time to do this is between 2:00-3:30? This is where their parent teacher conferences at elementary schools will come in handy. Teachers can learn what will work best for each family.

How will we provide internet access for students who are not in their own home each day (students who go to grandparents or babysitters). We will look into this issue.

Superintendent Tack - Milestone of graduation is still our commitment, we will be working with students who are struggling to get their diploma. As we are aware, we will start working with individual students or small groups who are having similar issues.

Director Grafton - Will HiCap still be an option? Yes, our HiCap staff will still be working with students through Zoom and other means.

Director Conrad - What about programs such as Welding/Construction? We will be using an extensive video conferencing system demonstrating the same we will be doing for things such as science. It is not ideal, but is the best option for now.

How will we be enforcing attendance? We are waiting on guidance from the state for more information on this.

Superintendent Tack explains that we are trying not to "yo-yo". It is incredibly important that our students and families have some consistency. If we were to open to in person, we run the risk of having in person school, then having to switch to distance learning, then maybe back to in person and then back to distance. This is not a program that will work well for families. As soon as we can be back safely we will be. The department of health will let us know when this is possible.

What is the plan for Running Start? Running Start goes through LCC so it will be dependent on what they decide. Kids are still able to participate.

We know the biggest challenges are childcare and internet access. We are working with outside agencies to try to meet this need. Director Moore states that even though this is incredibly difficult for families it is important for us to remember that our job and focus is not childcare, it is education and that is where our focus needs to remain.

Director Haas asks if this model will help students and staff when we do get to pivot to a hybrid model. Answer, yes, this will help a lot as students will have a plan in place already and will be able to continue.

Director Grafton - I have a lot of people asking me, why are we not going back to school? Superintendent Tack - With the metrics that came out from the department of health we have to listen. We are not health experts and have to lean on their recommendation. It would be negligent on our part to not listen. This is again the board's decision, but our recommendation is to follow the guidance of the health department.

Director Conrad - This is a hard decision for everyone.

Director Grafton - It doesn't feel like this is really the decision of the school board. Superintendent Tack - Yes, this puts the board in a very difficult position. That is one reason we can't have these conversations in private. We have these where all stakeholders can be present.

Director Haas - I do feel it is best to follow the health department guidance.

Director Moore states that even though this is incredibly difficult for families it is important for us to remember that our mission is not childcare, it is education and that is where our focus needs to remain.

Superintendent Tack - It is incredibly hard to not be face to face. Our goal is to support the whole child. This is what truly keeps me up at night.

Director Grafton - I've had a few people ask, if their high school student needs to "fill" their schedule, or if they can just take the required courses and be done. Superintendent Tack - I have also fielded a few of those questions, and my reply is that we are getting kids ready for post secondary options. Which means it helps them explore different options. Instead of meeting the minimum requirements, we are helping them see more of what is out there. We are helping them to be competitive when they are out there, even during this time that is important. Director Yore - this is the same model we pursue for in person education.

Director Huntington - What is the anticipated attrition rate for the online vs hybrid model. We had many kids do very little or were disengaged, what do we anticipate that to look like this fall? Assoc. Director DeWeert & Director Yore - We anticipate being able to engage more students in this program as the expectations were low in the spring. That will not be the case this fall. This is a fresh start. Kids won't have a choice just like with in person schools.

Director Huntington - What about elementary students who do not have great home support? Assoc. Director DeWeert & Director Yore - Hoping to pull back small groups of students who struggled in the Spring face to face so that we can start working on closing the gap. We had many staff members who went out of their way to reach students in the Spring and more are ready to do so now. Superintendent Tack - monitoring and intervening will be a top priority to all staff.

Director Huntington - In the past the schools have sponsored ACT/SAT testing, how will that look this year for those who need it? Assoc. Director DeWeert & Director Yore - This was actually a discussion at the high school this morning. One thing to know is that the majority of colleges are not even requiring this right now. They are offering incredible grace to students at this point. We will be working on it as soon as we are able to have small groups safely together.

Director Huntington - For students who need extra attention, is in person learning completely out? Assoc. Director DeWeert & Director Yore - for the month of September yes, but we are hoping to revisit that in October as a possibility. With those behind to graduate and special ed students to have first priority. Superintendent Tack - We have heard from many in the community that it is not just for those struggling, but for others so that we can engage with all. So this is definitely on our radar.
