"Open Campus" Regulations

Open Campus is a privilege whereby Junior and Senior students are allowed to leave the Shawano Community High School under the following conditions:

- 1. Only students that meet the credit requirements to be classified a Junior (12 credits) or a Senior (18 credits) will be eligible for Open Campus.
- 2. Only students that have a completed <u>Authorization to Leave During the Noon Hour</u> on file in the office will be eligible for Open Campus.
- 3. Failure to abide by any of the following will result in the loss of the Open Campus privilege for the remainder of the current semester:
 - a. Students may leave the building <u>only</u> during their scheduled lunch period.
 - b. Students choosing to leave the building at lunch must use the East Commons entrance only <u>and</u> display their ID card upon leaving.
 - c. At no time are students to linger or loiter outside the building or in the parking lot.
 - d. Students must drive in a safe manner and abide by all traffic laws on campus.
 - e. Students leaving the building must return for the beginning of their next scheduled class or study hall.
 - *** If you become sick during the lunch period <u>or</u> are unable to return to school after lunch and wish the absence to be excused, a <u>parent</u> must call the Office <u>immediately</u> to report the absence. No excuses will be granted after an absence has occurred.
- 4. A student <u>suspended</u> from school at any time during the school year will not be eligible for the Open Campus privilege.
- 5. A student identified as a "<u>Habitual Truant</u>" (unexcused absences on all or part of 5 days within a semester) will not be eligible for the Open Campus privilege.
- 6. The Open Campus privilege may be removed as a disciplinary consequence if deemed appropriate- i.e. tardiness, period truancies, etc.
- *** An 18 year old student with an "Adult Student Request Form" on file in the SCHS office may substitute themselves for "parent" in the above regulations. However, 18 year old students must comply with all regulations listed above.
