Subject: Agreement regarding Driving Students to or from Field Trips or School Activities

This is to confirm the following agreement between Waldron Area Schools (hereinafter referred to as "the School") and the Waldron Education Association (hereinafter referred to as "the Association") regarding the transportation of students to or from field trips or school activities.
