**Nashoba Valley Technical High School agrees to provide the privilege of parking a privately owned vehicle on school property to a registered student under the following conditions, subject to the regulations indicated below:**

\* Parking permits are issued through the Dean's Office. All outstanding balances must be paid to the Business Office **in full through the current school year** or a permit will not be issued.

\* The parking tag must be hung on the rearview mirror and visible at all times. If the student drives a different car to school the Dean's Office must be notified and the parking tag must be displayed.

\* Students do not have permission to give away their parking spots. Any changes to parking areas must be approved by the Dean's Office.

\* The students assigned a parking permit are responsible for following all school rules and regulations in the Student Parking section of the handbook at all times. They will wear a seatbelt, drive slowly and safely on school property, must not exceed the speed limit (15 MPH), and will obey the directions of the parking monitor. Students are responsible for their passengers.

\* Students are not allowed to park vehicles in the front of the building or at the Early Child Care Facility. The Gutierrez Company which owns the property directly across from Nashoba Tech to the Emerson Building and as far back as the Hampton Inn has informed us, per their liability insurance policy, that students **are not permitted to park on any property on Technology Park Drive**. Students parking in undesignated areas will receive a parking citation and be responsible for all towing expenses.

\* The student **must** obtain a pass from the Dean's Office to go out to their car during the school day.

\* Student drivers who accumulate two (2) or more unexcused tardies in one week will have their parking privilege suspended for a period of one week following the violation.

\* When being dismissed from school, student drivers will be allowed to provide transportation for themselves but not for fellow students. A parent, guardian, or other approved student contact must provide confirmation prior to dismissal.

\* Any violation of school policy or crime committed on the premises may be deemed as sufficient cause to void this contract. Severance clause: if any part of this contract is found to be in violation of any local, state, or federal statutes, its violation will not negate other agreements formed in this agreement.

\* This agreement may be amended at any time by the Dean's Office or school administration. In the event that changes are made, students and their parents/guardians will be notified via email and changes shall immediately become part of this agreement.

**This application, along with a copy of a student's driver's license and registration must be turned in by August 15th, in order to receive a parking permit for the next school year. Parking permits will be available for pickup one week before school starts on a designated day to be announced. Student parking is limited to student-designated parking areas by permit only. There is absolutely no student parking in the front parking lot. Available student parking is assigned with the following priorities: (1) students requiring handicap license plates, (2) seniors, and (3) underclassmen.**

I also agree that any violation of these parking regulations may result in suspension or revocation of my parking permit and the privilege of bringing my car to school.
