The Board approved Lunch checks totaling \$30,535.34, Escrow checks totaling \$23,264.44, and Activity checks totaling \$20633.86.

The Elementary Principal reported first place in the homecoming parade went to the Senior Class, 2^{nd} place was the 6^{th} grade and 3^{rd} place was the Junior High Students. Parent/teacher conferences were well attended

at the elementary school. The school had the reunification drill on Oct. 18th. Fire prevention week was held at the elementary school. Upcoming events are the Professional Development day on Oct. 20 and Fall break on the 21st. There will be a Lyceum at the Elementary on Nov. 15th. There will be an ECOC meting on Nov 16th and no school due to the Professional Development day.

Mr. Messersmith mentioned that the football team will be playing in playoffs on Oct. 20th. The volleyball team finished 4th in the Knox Co. Tournament. Unified Bowling practice has started. Bloomfield will have two teams. State X-C will be held in Kearney on Oct. 21st. Junior High wrestling will start on Oct. 24th. The conference vocal music contest will be held in Bloomfield on Nov. 7th. Mr. Messersmith would like the students in digital media and design to assist with the computerized alumni display.

Mr. Alexander reported that the NASB/NCSA state convention will be on Nov. $16^{th} - 18^{th}$. Federal applications are being completed and the school audit was on Oct. 19^{th} . The negotiations committee will be meeting with the BEA. State testing results have been released. There was only 53% attendance at the High School parent/teacher conferences. AQuestt results showed the Bloomfield district receiving an excellent. The reunification drill was held. It was improved upon from the last time we held this drill. Staff members were debriefed following the drill.

There were no committee reports.

Discussion items included the NASB conference and negotiations. Jason Hefner will be sending out a form for the Superintendent evaluation. The staff survey results were not available at the meeting. They will be shared at the next meeting. The cell phone policy was discussed. Mr. Alexander was going to check with other districts as to their policies. Students are unaware of the consequences that can happen by sharing pictures and texts. Discussion was held to possibly host a dual citizenship session. This would be open to students and parents/guardians. Board members were able to review the memorandum supplied by KSB school law.
