Semester tests were bumped up due to the snow and cold temperatures. Christmas break will begin on Dec. 22 with students returning on the 6th of January.

Bloomfield will be playing in the Creighton Holiday Tournament on Dec. 29th and 30th. The January board meeting will include the reorganizational meeting and Justin Jindra will begin his term on the BOE.
