a. Jenn Arlien presented the meeting minutes from June 14, 2017. A correction on the June minutes was made to change the approval meeting

- b. Jenn Arlien presented the Treasurer's Report. Aimee Copas shared we are currently up 20 members and representation at the National Convention was down due to members having other commitments.
