1. Call to Order—Audrey Faul

a. President Faul called the meeting to order at 10:00

2. Introductions—Audrey Faul

a. Everyone introduced themselves and gave a highlight from this year

3. Approval of Agenda—Audrey Faul

- a. President Faul added another item to New Business—e. New Administrators Conference
- b. Two other changes were made to the agenda. Additions were: 5e-region rep reports 7e-paperless meetings
- c. Lynn Wolff made a motion to approve the agenda. Mitch Jorgenson seconded. Agenda approved.

4. Secretary/Treasurer Report—Anna Sell

- a. Anna Sell presented the meeting minutes from the February 4, 2015, Executive Board Meeting. Dave Wegner motioned to approve the minutes. Joy Walker seconded. Report approved.
- Anna Sell presented the Treasurer Report. Total assets as of March 31, 2015- \$92,149.99. Chris Bastian made a motion to approve the Treasurer Report. Dana Carlson seconded. Report approved.

5. Reports and Discussion

- a. NAESP-Dave Steckler
 - i. We have 171 members currently and are waiting to hear about Goal Buster Status.
 - ii. Dave gave updates on the national convention. The numbers for this year's conference are down. However, according to information from the national level, the numbers in the summer are higher than spring meetings. Dave

 - ii. Dollars for Scholars and a possible partnership with BND was explained further. Further discussion took place among board members with feedback given to go back to the NDCEL board.
 - iii. Information was given out about how the university system and new requirements/ideas are being implemented and the development of a their teacher preparation programs. Further discussion took place among board members and possible feedback that could go to the NDCEL board.
 - iv. Chris gave information about the summer NDCEL Conference in June.

 - ii. There are exciting things happening in Washington right now. ESEA has not been reauthorized for 7 years. However, there is bipartisan participation happening right now with discussion centering around key elements of the reauthorization bill.

 - iii. Region 5, & 6 both will be getting new reps this spring.

 - i. Surveys indicated that people were very pleased with the conference

- iii. Jason gave more information about feedback from the survey. Speakers that were engaging and facilitated interaction with the audience received much more positive feedback. Participation was high and the registration fee paid is where most of the revenue is created from the conference.
- iv. Discussion took place about attendance at the banquet. This year 62 people that had signed up for the banquet did NOT show up, which equated to \$1200 that could have been used elsewhere for the conference. Possible solutions/ideas were discussed to deal with this problem for next year's conference.
