WV Dept of Ed Re-entry Map

By the Numbers

During a recent meeting of the Wood County Board of Education, Superintendent Will Hosaflook and board members discussed some of the financial and logistical challenges facing Wood County Schools this year, not only due to the COVID-19 pandemic, but also because of the changing ways in which students are receiving instruction.

Among the numbers discussed:


- **1,850** The number of Wood County Schools students enrolled in West Virginia virtual school. The number declined from an initial 2,400, some of which opted to return to traditional classes.
- 22 The "clicks" it takes to sign one student up for virtual school.
- 117 New support positions to help ensure the success of Wood County Schools students enrolled in virtual school. Though many of the jobs are part time, those teachers provided invaluable support services for students and families.
- 800 The number of "wifi hotspots" distributed to students in areas
 without reliable internet access. Officials estimate the hotspots will allow
 about 902 families to continue remote learning.
- 2 The number of people working full time to activate, distribute and track those wifi devices.
- **40** The monthly cost of each hotspot. The school system is paying about \$32,000 a month for 10 months to provide the wifi hotspots this school year.
- **11,904** The total enrollment for Wood County Schools, including virtual school students. Enrollment is down about 300 students this year.
- **10,000** Roughly the amount of state funding received per student. Since those annual funds are based on enrollment numbers, a 300 student drop equates to a roughly \$3 million loss of funding.
- 16 The number of teaching positions funded by \$1 million.

Stopping the Stoplight

Before the West Virginia COVID-19 mapping system was created, Wood County Schools developed a Stoplight System for its fall re-entry plan. The idea was to make it easy for parents and educators to know what kind of instruction would occur each week by using a green/yellow/red code.

But after the state system was unveiled with its own rainbow of colors and meanings, things got confusing. The Wood County system is independent of the state map, but uses many of the same colors and terms. To make it easier for everyone, Wood County Schools will now simply say the kind of instruction which will occur: In-person, blended or remote.

"In-person" is like regular schools with students attending classes at the school four (4) to five (5) days a week. COVID-19 precautions such as masks, social distancing and frequent handwashing and sanitizing of surfaces will still be in place.

"Blended" is when students attend on campus two (2) days per week and received off campus instruction three (3) days a week.

"Remote" means students are engaged in learning five (5) days a week off campus.
