<u>Superintendent's Report</u> – The Superintendent presented a written report explaining the new credit card payment procedure through PayPal that allows parents the opportunity to purchase lunch in that manner, and the ease of the transaction and the record keeping function it provides. Here is a list of TEF Grants that were applied for:

One to One Chrome Books for 6th Grade - Shari Muehlich, Shanna Oyer, Ashley Page, Rachel Zobrist, Jamason Isenburg, \$7,260., Starting in the 6th Grade, the staff would like to incorporate a one-to-one Chromebook for each student (80 Chromebooks). The student would then have the Chromebook each year until the 8th grade. Chromebooks are integrated into the free Google Apps for Education Service that the School District will be utilizing starting in the 15-16 school year.

Double Dip Career Fair - Michelle Keech, Michele Williams - * Suggested Funding: \$3000, \$3,900. - Career Fair put on by the seniors for the underclassmen... Funds would be needed to cover substitutes, motivational guest speaker, presentation materials, snacks, lunch and prizes.

LEGO Education StoryStarter - Creativity in the Elementary Classroom: The Building Blocks for 21st Century Learning - Kate Lang, \$1,225.88, LEGO Education StoryStarter is a hands-on learning tool that enhances students' reading, writing, speaking and listening skills. They will use the software to photograph, write and publish their stories.

Keyboarding for Success - Teresa Delinski - \$800., Students are practicing beginning keyboard skills as early as Kindergarten. The keyboards in the technology lab are traditional keyboards with no way to cover the letters so students begin to memorize the keyboard. These keyboards are color coded so students use the colors to help reinforce what fingers are needed for what keys.

Science Technology for STEM Education - Simon Merila, Meghan Bagby, Shelly Sisson - \$5,974.28, Two gel electrophoresis units as well as 6 Vernier standalone interfaces with appropriate sensor equipment to provide more efficient laboratory results.

Books, Books and more Books – NOT FUNDED THROUGH TEF....Rachel Nehmelman - \$5,000. - Add new Fiction/Non-Fiction titles to the school library at the Middle School and High School level to complete series that were started but we haven't had the funds to finish, and to update the library with newer book titles. **Flipped Classroom Enhancement -** Heather Rice - \$1,050. - Enhance the current Flipped Classroom Model in the eighth grade classroom by providing two more iPads, a stipend for iPad apps, headphones and splitter, and software for improved video recording. Begin to incorporate the Flipped Classroom Model into the seventh grade mathematics classroom.

Classroom Desks – **NOT FUNDED THROUGH TEF...**Katie Brand, Genna Brown - \$5000, - Purchase individual desks for each student in order to provide a physical separation from peers, allow for flexible seating, provide storage for student belongings, allow for less distractions and teach responsibility and organization skills.

Blast Off Google – NOT FUNDED THROUGH TEF...Michelle Keech, Teresa Delinski - \$2,198. - To become Google Certified Educators and share their knowledge with other teachers through Professional Development throughout the year. Create six Google Drive Professional Development Classes for Teachers. Create an online course for students to use during Careers to become Google Drive Experts as they begin High School.
