1. **PARENT/GUARDIAN PHOTO I.D.** A driver's license or any other photo I.D. is acceptable.
 - The biological, foster or adoptive parent may enroll the student.
 - Guardians must have proper guardianship forms signed and notarized or a copy of court authorization.
 - Custody documentation is required, if applicable.
 2. **DOCUMENTATION OF CHILD'S DATE OF BIRTH** Please bring ONE of the following government issued proofs:
 - Birth Certificate (full size certificate, showing parent's names as well as child's is preferred)
 - Valid passport
 3. **PROOF OF RESIDENCE** To enroll, the student's parents or legal guardian and the student must be a full-time resident in the Re-1 Valley School District. (NOTE: Disconnect notices are not acceptable forms of proof of residence)
 - a. ***If you own your home***, please **bring TWO of the following** (only originals will be accepted):
 - Warranty Deed, Deed of Trust, or Bill of Sale
 - Purchase contract with possession date or closing date not more than 90 days out
 - Current utility bill (i.e. Xcel Energy, water, cable, trash) or mortgage statement -- your name and address must be clearly marked (both portions of a bill are required, property/service address must match mailing address) – last or current month; disconnect notices are not accepted
 - Homeowner's insurance or property tax bill for current year (property/service address must match mailing address within Re-1 Valley School District boundaries).
 - b. ***If you rent***, please **bring TWO of the following** (only originals will be accepted):
 - Current Signed Lease or Rental Agreement
 - Lease agreement with possession date not more than 60 days out
 - Current utility bill (i.e. Xcel Energy, water, cable, trash)-- your name and address must be clearly marked (both portions of a bill are required, property/service address must match mailing address) – last or current month; disconnect notices are not accepted
 - Renter's insurance
 - c. ***If you are living with another family*** – **ALL of the following are required:**
 - Declaration of Residence must be completed and signed by the owner/renter of the residence with whom you live stating the length of time you will be staying in the presence of school or district personnel.
 - Two proofs of address from the owner/renter of the residence. (See required documents above)
 - Current proof of your residence at that address (i.e. bank statement, insurance statement, new Colorado drivers license receipt, US Postal Service official address change form, bills received including cell phone, etc. with your name and address clearly listed)
 - d. Families who have changed their address and currently have a student enrolled in Re-1 Valley Schools will need to verify their new address by providing the required documents for proof of residence listed above.
- Note:** Please notify us if you are unable to provide documentation because of loss of housing or economic hardship.

Students needing additional assistance in reading and/or math will be placed based upon testing scores in place of all other Exploratory classes. *(class cannot be chosen, students will be placed based on scores)*

1. How It's Made - Johnson

Dive deeper into How It's Made videos and learn how everyday things we use are made.

2. Be Proud of Who You Are!-Knaub

You are a wonderful and unique individual with many strong positive traits. You might have strong qualities and traits that aren't developed yet. Discover how to boost your self-esteem and build self-confidence, find your strengths and what makes you unique. Learn to think positive thoughts and find what motivates you to strive to be the best version of yourself.

3. Chess Club—Witherspoon

Chess is one of the oldest games in the world. In one study, students increased their IQ scores after playing chess for only 18 weeks! In this class you will learn the basics of Chess and how to improve your game. Brief lessons, solve chess puzzles, and of course, play a lot of chess!

4. The World Wars - Warren

This class will explore the causes, outbreaks, major events and battles, consequences, and people of World War I and WWII. We will learn from a variety of activities such as interactive notebooks, videos, investigations, and simulations.

5. American History in a Flash - Warren

Explore American History through "America the Story of US". WE will cover each topic in a flash while focusing on certain themes and patterns. You will have an opportunity to study a topic of your choice more in depth throughout the class.

6. History of Math – Zaba

Writing numbers and solving problems using Egyptian hieroglyphics. Learning about parabolas and projectile motion to create cannons and catapults like medieval times. Discovering zero is only 800 years old and what did people do without zero. Plus MORE!

7. Designing the Future – Witherspoon

Jobs of the future will require people who can solve complex problems with sophisticated technology. You will learn how to tap into your own innate creativity to design games, create physical objects to interface with computers and use robots to overcome obstacles.

9. Current Events - Johnson

Stay up to date on weekly things happening in the world from sports, science, health, business and arts and entertainment.

10. Math Games – Zaba

Card games, board games, game shows, plus more, have tons of math and logical thinking. Learn about a game and the math involved then play it and apply our new knowledge to be better at the game.

11. Just Dance – Busmente/Serrato

Students will be introduced to principles and concepts for effective rhythmic motor development through dance. Students will learn and perform various genres of dance.

12. Cartooning – Knight

Learn the history of cartooning, where it originated from and changes through the years. Class will include drawing.

13. Fables, Fairy Tales, Myths & Legends–Knaub

Analyze storytelling traditions, discover how life lessons are learned from understanding fables and how fairy tales influence society. Also, explore myths to explain events in nature and identify connections to cultures with legends. Create your own tall tale, myth or legend!

14. A Puzzle A Day– Zaba

Puzzles are brain food! Solve different types of puzzles from word puzzles to number puzzles, jigsaws and rubics cubes. Your brain will get a workout as you have fun!

15. Yoga—Busmente/Serrato

30 minutes of stretching, relaxation and finding your center to start of your day. Will need to wear flexible clothing.

16. All School Musical - Performers

6th-8th grades (\$10 fee) (2nd Semester)
Attention all actors/singers! The Musical is your chance to explore the craft of theatre! All students who sign up will audition for a role and take part in the ensemble onstage, both acting and singing the songs of the play and we will focus on helping you learn to act on stage. **

17: All School Musical- Orchestra

6th-8th grades (\$10 fee) (2nd Semester)
We need musicians to play in the orchestra for the numbers the actors will sing for the musical.**

20. Musical Stage Hands-Sets & Design

7-8th grades (\$10 fee) (2nd semester)
We need students to help create artistically superior set designs and props and help with costumes as well as the house lighting and sound. **

***After returning from Spring Break MUSICAL cast will be required to attend some mandatory evening practices. The only excused absence from the evening practices will be for other school-related extra-curricular activities*

19. Drumline – Mitchell

7-8th grade (1st semester)

In this exploratory you will learn the basic skills of a marching drumline. Including, rhythm reading and counting, cadences, proper technique and skill, and marching. This is a performing class so make sure you are ready to have fun AND play for audiences. *Students may be asked to purchase drumsticks for this exploratory.*

Jazz Band (\$20 fee)– Mitchell (Full year)

Select band, **by audition only**, which performs for many events throughout the community. Open to all types of instruments. **Students are chosen based on audition and will pay a fee of \$20 to cover costs if chosen.**

ART COURSES

Art -7th or 8th grade (course includes a \$10 fee)

All the art courses give students the challenge of strengthening their critical thinking through problem solving activities. Artists will learn the Elements & Principles of Art while working with various mediums. This course will introduce students to the many different methods of creation available. We will learn how to analyze artwork and explore the vast history of art.

MUSIC COURSES

Band (course includes a \$20 fee)

Band is for students with previous experience. The band plays music of greater difficulty and a variety of musical literature. Students provide their own instruments except the French horn, baritone, tuba, and double reeds, which are provided by the school. The group presents three or four concerts each year and also performs in band festivals and continuation. Students may also participate in a solo/ensemble festival in the spring. They may also march in the Logan County Fair parade in August. **8th grade also performs at Continuation.*

Choir (course includes a \$5 fee)

Students will learn to sing a variety of music in multiple languages and parts. They will learn music theory and sight-reading in conjunction with singing music. Concert performances are required for this course. There will be 2-4 concerts per year, or more if the opportunity presents itself. Students will also be able to participate in solo and ensemble festivals. This class may include travel for festivals and competitions. **8th grade also performs at Continuation.*

IMPORTANT REQUIREMENTS

Students will be allowed to select 4 semesters of elective coursework. PE is required and will take one semester each year. **Please note that Band and Choir count as 2 semesters.** All other elective classes are 1 semester classes.

- ⇒ Students **must take** *at least one* semester of Tech courses during 7th or 8th grade.
- ⇒ Students **must take** *at least one* semester of Art or Music during 7th or 8th grade.

COURSE DESCRIPTIONS

TECHNOLOGY COURSES

Tech Ed (course includes a \$5 fee)

This semester course is designed to teach and use technologies which impact our lives in this fast paced information age. Students will choose from a variety of modules and complete projects using an independent study lab curriculum. Photoshop, Flight Simulation, Digital Video, Vinyl Sign Cutting, Lego Robotics, and Bridge Building are some of the modules available. Additional class projects may include: Moviemaker and online portfolios.

Exploring Technology (course includes a \$5 fee)

This semester course is a pre-engineering and design course that incorporates many STEM principles. We study Technology Concepts, Manufacturing, Electric circuits, plus Design and Engineering. Some of the projects include: a manufacturing simulation, transportation vehicle design and testing, and skyscraper design. We also learn the basics of Sketch-Up 3-D design software and scale drawing principles.

Digital Art (course includes a \$5 fee)

This semester course is designed to teach how art and technology interact to create media or art for today's world. Topics may include: A Review of the Elements of Art, a style of art study, and other creative activities. We have available a classroom set of Wacom Drawing Tablets that students will use in the Fireworks and Krita software programs to create unique digital art projects. Online digital portfolios are also created to display student work.

COMPUTER APPLICATIONS COURSES (continued on next page)

Computer Applications I (course includes a \$5 fee)

This is a one semester course. This course will include application driven instruction in word processing, database management, spreadsheet design, presentation formats, Internet use & safe practices, and fundamental computer terminology. The class will also include an introduction to coding where students engage in hands-on programming tasks. Using the Scratch programming language, this course allows students to create authentic artifacts and engage with computer science as a medium for creativity, communication, problem solving, and fun. Emphasis will also be placed on improvement of keyboarding skills for both speed and accuracy. **Frequent absences make success in this class very difficult.**

Introduction to Digital Photography (course includes a \$5 fee)

This course will introduce students to the basics of digital photography skills including camera functions, basic photo composition, and photo editing skills. Through a variety of assigned projects, students will engage their creativity by photographing a range of subjects, and learn to see images in different perspectives. *Cameras are provided.*

Computer Applications II (8th grade) (course includes a \$5 fee)

This one semester course expands upon the Computer Applications I class. This cross curriculum oriented course offers capstone assignments to introduce students to business projects. Students will learn how to master MS Office and Google applications with emphasis placed on word processing, database management, spreadsheet design, presentation formats, and publishing. All applications will be completed in conjunction with Internet research. The class will also include basic coding where students engage in hands-on programming tasks. Using the Scratch programming language, this course allows students to create authentic artifacts and engage with computer science as a medium for creativity, communication, problem solving, and fun. Students will also learn the proper and safe techniques to research on the Internet and concepts dealing with entrepreneurship and website building. **Frequent absences make success in this class very difficult.**

PHYSICAL EDUCATION HEALTH

(at least one PE **required** each year)

*Only 3 semesters of PE are allowed-if you took two in 7th, only 1 will be assigned in 8th

Physical Education and Health (course includes a \$3 fee)

Every student will be enrolled in one semester of this course.

Physical and Health Education courses provide students with the knowledge, experience, and an opportunity to develop skills in a variety of sports or activities (for example, team sports, individual/dual sports, recreational sports, and fitness/conditioning activities) integrated with instruction in personal health and development (nutrition, self image and self improvement, making decisions, resolving conflicts, communication skills, social skills, assertiveness, coping with anxiety, coping with anger, advertising, violence and the media, smoking/alcohol/marijuana myths and realities). **Students will need tennis shoes, a swimsuit, and an SMS PE shirt** (from Stegers's or Garretsons Sport Center).

Information about Applying for Free or Reduced-Price School Meals

Dear Parent/Guardian:

Children need healthy meals to learn. RE-1 Valley School District offers healthy meals every school day. Breakfast costs **\$1.50** and lunch costs **\$2.35 for elementary and \$2.75 for secondary. Your children may qualify for free or reduced-price school meals.** Students in all grades that qualify for free or reduced-price meals will receive breakfast and lunch at no charge.

This packet includes an application for free or reduced-price meal benefits, and a set of detailed instructions. You can also find applications at all district school offices or online at re1valleyschools.org in the Menu under Departments and Food Service.

Below are common questions and answers to help you with the application process.

1. WHO CAN RECEIVE FREE OR REDUCED-PRICE MEALS?
 - a. All children in households receiving benefits from the Supplemental Nutrition Assistance Program (SNAP), the Food Distribution Program on Indian Reservations (FDPIR) or Temporary Assistance for Needy Family (TANF/Colorado Works – Basic Cash Assistance or State Diversion), are eligible for free meals.
 - b. Foster children that are under the legal responsibility of a foster care agency or court are eligible for free meals. Foster children may be added as a household member of the foster family if the foster family chooses to apply. Including foster children as household members may help other children qualify for benefits. If the foster family is not eligible, it does not prevent a foster child from receiving benefits.
 - c. Children who qualify for their districts Head Start program are eligible for free meals.
 - d. Children who meet the definition of homeless, runaway, or migrant are eligible for free meals.
 - e. Children may receive free or reduced-price meals if your household’s income is within the limits on the Federal Income Eligibility Guidelines. Your children may qualify for free or reduced-price meals if your household income falls at or below the limits on this chart.



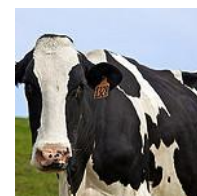

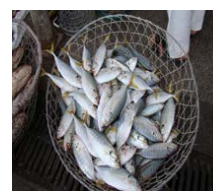

RE-1 Valley Reunification Plan

Student/Family Reunification Procedures Following a School-Based Emergency

- If there is an emergency that requires evacuation and relocation, wait for official instructions that will be communicated using our messenger system. This telephone and email message will inform you what has happened and what you should do (if anything.)
- Do not call the school since they will be busy managing the incident.
- Do not go to the school unless instructed. Traffic jams impede the movement of emergency vehicles and can make a difficult situation worse.
- Understand students will be kept at the reunification site.
- Pick up your child at the reunification site as instructed by officials.
- Bring a government issued form of identification (e.g. driver's license, passport, etc.) and check in with school officials.
- Report to the designated Parent Check-in area. Stations will be set up directing you where to go, report to the correct line as directed.
- At the reunification site(s), students will be kept in an area separate from the check-in area for parents/guardians. Parent/guardians will check-in using appropriate identification and sign student(s) out. The student(s) will then be brought to the reunification area.
- Wait for your child to be brought to the reunification area.
 - Students will only be released to parents or guardians who have presented acceptable identification and who are named on the student's emergency information card.
- Students will remain at the reunification site until a designated person has taken responsibility for the child's welfare. Other adults who may be asked to pick up your child must be identified in advance on the student emergency information card.
- Students transported to hospitals will have a label completed in duplicate.

Acceptable Use Agreement for Students

Code of Conduct

Students in third grade and higher grade levels

In accordance with applicable law and Board policy concerning student suspensions, expulsions and other disciplinary interventions, the principal or designee may suspend or recommend expulsion of a student in third grade and higher grade levels who engages in one or more of the following activities while in school buildings, on district property, when being transported in vehicles dispatched by the district or one of its schools, during a school-sponsored or district-sponsored activity or event and off district property when the conduct has a nexus to school or any district curricular or non-curricular event.

1. Causing or attempting to cause damage to district property or stealing or attempting to steal district property.
2. Causing or attempting to cause damage to private property or stealing or attempting to steal private property.
3. Willful destruction or defacing of district property.
4. Commission of any act which if committed by an adult would be robbery or assault as defined by state law.
5. Committing extortion, coercion or blackmail, i.e., obtaining money or other objects of value from an unwilling person or forcing an individual to act through the use of force or threat of force.
6. Engaging in verbal abuse, i.e., name calling, ethnic or racial slurs, either orally or in writing or derogatory statements addressed publicly to an individual or a group that precipitate disruption of the district or school program or incite violence.
7. Engaging in hazing activities, i.e., forcing prolonged physical activity, forcing excessive consumption of any substance, forcing prolonged deprivation of sleep, food or drink, or any other behavior which recklessly endangers the health or safety of an individual for purposes of initiation into any student group.
8. Violation of the Board's policy on bullying prevention and education.
9. Violation of criminal law that has an effect on the district or on the general safety or welfare of students or staff.
10. Violation of any Board policy or regulations, or established school rules.
11. Violation of the Board's policy on weapons in the schools. Expulsion shall be mandatory for bringing or possessing a firearm in accordance with state and federal law.
12. Violation of the Board's policy on student conduct involving drugs and alcohol.
13. Violation of the Board's violent and aggressive behavior policy. Students in third grade and higher grade levels
14. Violation of the Board's tobacco-free schools policy.
15. Violation of the Board's policies prohibiting sexual or other harassment.
16. Violation of the Board's policy on nondiscrimination.
17. Violation of the Board's dress code policy.
18. Violation of the Board's policy on gangs and gang-like activity.

19. Throwing objects, unless part of a supervised school activity, that can or do cause bodily injury or damage to property.
20. Directing profanity, vulgar language or obscene gestures toward other students, school personnel or others.
21. Lying or giving false information, either verbally or in writing, to a district employee.
22. Engaging in scholastic dishonesty, which includes but is not limited to cheating on a test, plagiarism or unauthorized collaboration with another person in preparing written work.
23. Making a false accusation of criminal activity against a district employee to law enforcement or to the district.
24. Behavior on or off school property that is detrimental to the welfare or safety of other students or school personnel, including behavior that creates a threat of physical harm to the student exhibiting the behavior or to one or more other students.
25. Repeated interference with the district's ability to provide educational opportunities to other students.
26. Continued willful disobedience or open and persistent defiance of proper authority including deliberate refusal to obey a member of the district staff.

Students in preschool through second grade

In accordance with applicable law and Board policy concerning student suspensions, expulsions, and other disciplinary interventions, the principal or designee may suspend or recommend expulsion of a student in preschool, kindergarten, first grade, or second grade who engages in one or more of the following activities while on district property, in a school building, in a district or school vehicle, at a district or school activity or event, or off district property when the conduct has a nexus to school or any district curricular or non-curricular event:

1. Violation of the Board's policy on weapons in the schools. Expulsion shall be mandatory for bringing or possessing a firearm, in accordance with federal law.
2. Violation of the Board's policy on student conduct involving drugs and alcohol.
3. Conduct that endangers the health or safety of others.

Student Discipline

The Board believes that effective student discipline is a prerequisite for sound educational practice and productive learning. The objectives of disciplining any student must be to help the student develop a positive attitude toward self-discipline and socially acceptable behavior.

All policies and procedures for handling student discipline problems shall be designed to achieve these broad objectives.

The Board, in accordance with applicable law, has adopted a written student conduct and discipline code based upon the principle that every student is expected to follow accepted rules of conduct and to show respect for and to obey persons in authority. The code also emphasizes that certain behavior, especially behavior that disrupts the classroom, is unacceptable and may result in disciplinary action. The code shall be enforced uniformly, fairly and consistently for all students.

All Board-adopted policies and Board-approved regulations containing the letters "JK" in the file name constitute the discipline section of the legally required code.

The Board shall consult with administrators, teachers, parents, students and other members of the community in the development and review of the student conduct and discipline code.

Remedial discipline plans

The principal may develop a remedial discipline plan for any student who causes a material and substantial disruption in the classroom, on school grounds, in school vehicles or at school activities or events. The goal of the remedial discipline plan shall be to address the student's disruptive behavior and educational needs while keeping the child in school.

Discipline of habitually disruptive students

Students who have caused a material and substantial disruption on school grounds, in a school vehicle or at a school activity or sanctioned event three or more times during the course of a school year may be declared habitually disruptive students. Any student enrolled in the district's schools may be subject to being declared a habitually disruptive student. Declaration as a habitually disruptive student shall result in the student's suspension and/or expulsion in accordance with Board policy concerning student suspensions, expulsions and other disciplinary interventions.

Distribution of conduct and discipline code

The conduct and discipline code shall be provided to each student upon enrollment in elementary, middle/junior high and high school. The district shall take reasonable measures to ensure each student is familiar with the code. Copies shall be posted or kept on file in each school of the district. In addition, any significant change in the code shall be provided to students and posted in each school.

BUS RULES & CONSEQUENCES

Rules

1. Follow directions the first time they are given
2. Stay properly seated at all times, keeping hands, feet and objects to yourself.
3. Swearing, unacceptable language, rude gestures and loud noises are not permitted.
4. Be courteous and respectful.

Consequences

1. Verbal/Written Warning Conduct Report to principal, with possible assigned seat.

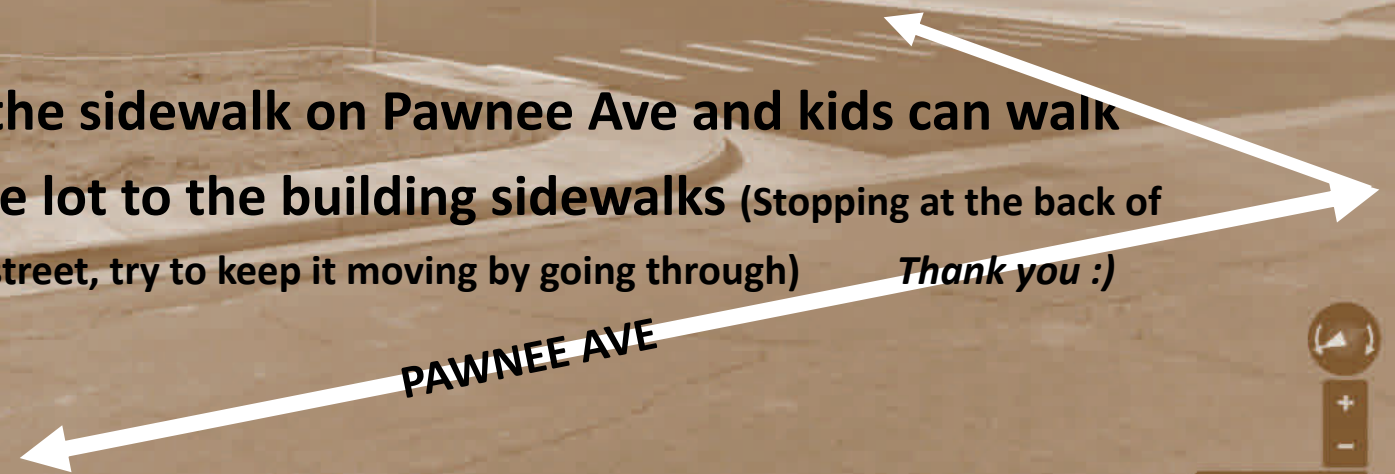


This back lot is off limits to thru traffic. Buses and staff only in the rear parking lot and entrances.

Students will be required to earn a minimum of 18 points each year in order to be promoted to the next grade level. Students must score one point in each of the academic and assessment categories.

A minimum of 18 points per year must be acquired to proceed to the next grade. ***8th Grade Students who do not meet this requirement, or have any unpaid fines/fees, WILL NOT be allowed to participate in Continuation exercises.***

Academics (Each Quarter and Final Grade) - 20 points maximum

- 1 point: Passing 1 of 4 core classes
- 2 points: Passing 2 of 4 core classes
- 3 points: Passing 3 of 4 core classes
- 4 points: Passing 4 of 4 core classes

Assessments – 2 points maximum

- 1 point for reaching growth goal on NWEA test (M & R)

Attendance – 3 points maximum

- 1 point for 90%
- 2 points for 92%
- 3 points for 95%

Unified Arts/Exploratory – 4 points maximum

- 1 point: Pass all Unified Arts and Exploratory classes each quarter.

Opportunities at Sterling Middle School

There are many educational opportunities available during the school year for students to succeed. (Extended Day, Before and After-School Tutoring, etc.)

*Extenuating circumstances shall be taken into consideration by a committee made up of the principal, a grade level teacher, counselor, and grade level resource teacher.

- May participate in Sterling Middle School Summer School. (\$100 per course needed to be taken)
- May take certified and approved correspondence course over the summer. (At own expense)
- Will review current statewide testing results in August (providing they arrive prior to the start of school) to see if enough points would be scored for promotion.
