PERMITS

Applications are available in the library and career center. Work Permits must be renewed at the start of each school year or at the time the student obtains a new job. Work permits are required all year, not just when school is in session. Work permits are taken by the student to the employer. Work permits also serve as an age certification and states the maximum hours a minor may work based on their age(Ed.C.49160).

Work Experience Education(WEE)

WEE is a work-based learning course of study that offers internships and employment combined with instruction in critical workplace skills. Students will develop ready-to-work attitudes/interview skills; financial literacy; knowledge of workplace safety and rights as workers; business operations; how to read an earnings statement and know what payroll deductions to expect; career decision making; making a career goal plan and much more.

Availiable WEE Courses

A student satisfactorily completing the WEE program requirements may earn a maximum of 40 semester credits made up of one or a combination of two or more of the following identified below.

Career Technical (CTWEE)

Students who have or are currently taking a CTE course will be placed in an industry related internship that will reinforce and extend their vocational training. Students can earn ten (10) semester credits for each semester with a maximum of forty (40) semester credits. (EC§ 51760.3, § 51762.S(b)(f) & CCR. TS§ 1635)

Exploratory (EWEE)

Through observations, job shadowing, workplace tours, and classroom instruction students will learn employability skills and explore various industries and careers. The student may be required to perform non-paid work activities while exploring the occupation on a limited, periodic, and sampling basis. Students can earn ten (10) semester credits for each semester with a maximum of twenty (20) semester credits.

General (GWEE)

Students will earn credit through paid employment and classroom instruction focused on employability skills and workplace awareness. Students in GWEE require a work permit and MUST secure paid employment prior to enrollment. Students can earn ten (10) semester credits for each semester with a maximum of forty (40) semester credits.


