In partnership with Lincoln Health and the Family Care Center, Influenza vaccinations will be offered to BRES and BRHS students this **October (date to be determined)**. This will be a one-day flu clinic.

Flyers with more information and permission sheets are coming home today! If you would like to have your student receive the flu vaccine at school we must have your permission slip returned to the school nurse no later than Friday, October 9th.

- > Please read the vaccination information sheets attached to this letter.
- ➤ If you would like your child to receive the influenza vaccination, please complete the Health Screen & Permission Form and return it to the school no later than **October 9th**. This form must be filled out completely or we will be unable to give your student the immunization at school.
- > There is no charge to you for the flu shot for a student under the age of 18. For a student 18 years or older a charge may be incurred if not covered by insurance.
- > This will be the **only day** flu shots are offered at the school.

BRES Tardy Policy

A Section From the BRES Handbook Regarding Tardy Policy

Parents are obligated to call the school from 7 to 8 am on the days their child will not be present, if you do not call, your child's absence will be recorded as unexcused.

Our bell rings at 7:45. Students who arrive after 7:50 will need to check in with the staff in the front office.

Students who arrive after 10 am will be considered present for a half-day. Students who are dismissed after 10 am will be marked present for a half-day. Students who enter school after 1 pm will be marked absent for the entire day.

Students who arrive after 9:30 am will not be allowed to participate in after school activities. Exceptions will be granted if the tardiness is due to appointments that could not be scheduled outside of school hours. Parents are urged to make medical appointments outside of school hours.
