Unfortunately, due to the pandemic, we do not have year end data for ISAT or IRI. Based on our most recent Istation data in February, 2020, 71% of students in grades K-5 scored proficient. In addition, only 8% of students in grades K-5 scored below basic. These results indicate that we would have likely met our targets on the K-3rd Grade IRI. We did not have interim data or comparable data for our targets on 3rd through 8th grade ISAT targets to make a predicable estimation of our effectiveness in those area. These results indicate that our efforts outlined in our Literacy Intervention Plan likely would have been effective.
