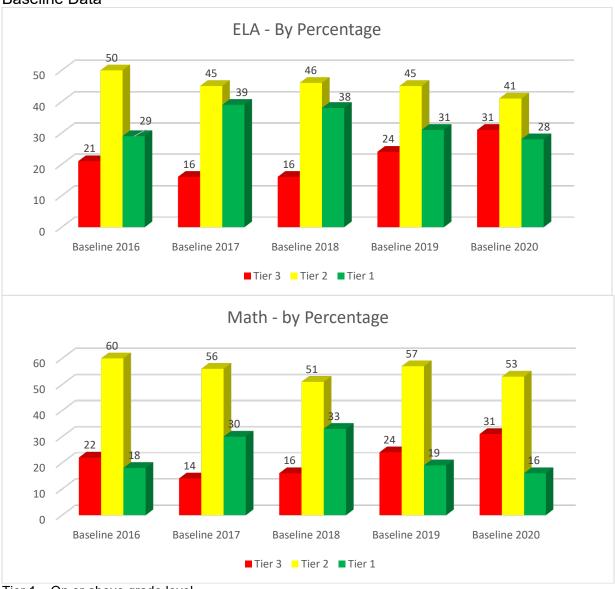

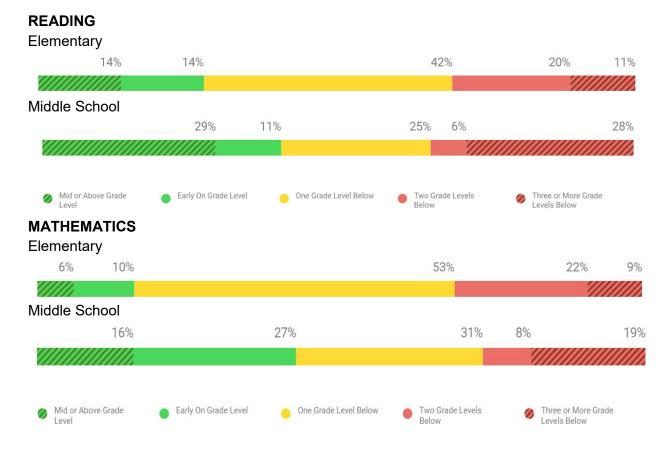

Board President Wendy Dyment called the meeting to order at 7:00 PM and led the assembled in the Pledge of Allegiance to the Flag.

CALL TO ORDER BOARD

#### 3.0 Presentations PRESENTATION

 a. Amy Webb, Committee on Special Education (CSE) and Committee on Preschool Special Education (CPSE)
 Chairperson, presented to the Board on the Special Education process and programs. She noted that it is normally in the elementary grades that struggling students are found to need services. The special education program provides daily services to the students.

The Child Study Team (CST) meeting is held on a struggling student and the team determines the level of services that is needed for the student. The CPSE referrals are normally through the County and our in-house preschool classes. The student may qualify for services such as academic intervention, counseling, speech and language (S/L), occupational therapy (OT), and/or physical therapy (PT). If the CST finds that the child struggles in two moderate areas or one severe delay in any area, he/she would qualify for services through special education. An initial meeting of the CSE or CPSE Committee would convene. The initial meeting has to have the parent/guardian present. An Individual Evaluation Program (IEP) would be developed as a result of the meeting, evaluations, and test results. Mrs. Webb reviewed some of the contents of the IEP. Once the Board of Education approves the recommendations of the IEP, the student can receive his/her services. The Committee has to meet at least one time a year on the student's IEP.

Mrs. Webb went over the various programs and placements that Westfield has and described the ratio of teacher to students. The related service programs were reviewed - Physical therapy is contracted out with Westfield Memorial

Hospital and the therapist provides the service in-house. There are two speech and language pathologists, one certified occupational therapist and a certified occupational therapist assistant, a social worker, middle school counselor, high school counselor and one full-time school psychologist and a half-time school psychologist in-house as well as two full-time nurses.

Mrs. Webb noted that all preschoolers in-house receive speech and language services. She mentioned that there have been some students with special needs transfer into the District.

Mrs. Webb reviewed the qualifications of a 504 Accommodation Plan. She noted that in order to qualify, the student would need to present with medical concerns which would impact his/her education. The Plan will provide classroom and testing accommodations for student with diagnoses. Mrs. Webb stated some of the areas of medical needs for a 504, such as diabetes, allergies, asthma, as well as other diagnoses. She described the eligibility for services for a 504 Plan and Individuals with Disability Act (IDEA).

Mr. Tarpley asked what the teachers and staff are seeing with the students this school year due to the COVID-19 situation last school year. Mrs. Webb noted that the students need the contact with his/her provider in order to meet the needs. She said there are parents that work with their child and there are others that cannot due to other circumstances. Mr. Tarpley asked Mrs. Webb if the remote learning for the special needs students was a failure? She noted that it is certainly was not helpful and some students struggle sitting at a computer and they need to be able to move around. Mrs. Webb felt that the students suffered.

Mr. Tarpley asked what type of comments have been received from parent's concerning the remote learning. Mrs. Webb commented there was a lot of trouble communicating with parents. Some parents do not have internet access. There were some home visits made, zoom calls, and phone calls. Mr. Tarpley asked how many students were in the program. Mrs. Webb stated that in the 2019-20 school year, there were 130 CSE students, 14 CPSE students and 53 504 students. For the 2020-21 school year, there are 128 CSE, 12 CPSE and 56 504 Plans. These numbers do not include students who entered the district today, Monday, September 28 2020.

Mr. Cockram asked if the ongoing services in the IEP are making a difference with the students. Mrs. Webb stated that if the Board sees a reduction in services, then the students are doing better. Dr. Rockey also stated that the graduation

numbers and test scores will provide information as to how the students are performing as well. Mr. Cockram asked how does the school personnel know how much the services are going to cost. Mrs. Manzella noted to look at the CSE recommendations. Dr. Rockey noted that here are spaces for more students in all areas except for S/L. The S/L pathologists are booked up and need to take paperwork home to do. There are daily notes that need to be inputted into IEP Direct per student. Mrs. Webb noted that if a student needs an evaluation, the S/L pathologist would not be able to provide services to another student.

Mrs. Manzella noted that the staff keep good control over expenses in the special education program. Mrs. Webb noted that it is the goal of the 1:1 aide to wean the student off of the one-on-one services but normally once that is done, the aide will have someone else to service. Mr. Cockram noted that is it not obvious of the funds for special education services. Mrs. Hagen stated that the school adopted the IEP Direct program for the tracking of services. Mrs. Webb stated that if a child moves into the district that we have to provide services.

CSE, CPSE, and 504 Accommodation Plan should be student's. On page 3, #4421, it was asked why it is stated as being a virtual meeting and not a zoom meeting. On page 4, #4299 under board information, it should read "The student's parents were not present for the meeting via phone conference."

#### 6.0 Public Comment

**PUBLIC COMMENT** 

President Dyment explained the requirements for the public comment at the Board of Education meetings.

Mr. Forester, of 2 Bryant Street, Fredonia, NY, wanted to comment on the S/L services provided by the two S/L pathologists. He noted that currently, we have 30 IEP students which is more than they have ever had. Mr. Foster stated that there are 60 students, which are non-IEP students. These students need articulation/speech improvement services and the pathologists are not able to provide these services due to the caseload each therapist has daily. He noted that group therapy in Kindergarten benefits all students and this service cannot be performed due to the caseload of the pathologists. Mrs. Hagen asked if there is a handout that can be provided to the classroom teachers. Mr. Forster stated that this is what a speech and language pathologist does and it should not be up to the classroom teacher. The pathologist targets certain areas of the student's needs not the teacher. The teacher can touch areas of speech for all students. Mrs. Webb wanted to clarify that the 60 students mentioned earlier are not IEP students.

#### 7.0 Action Items

#### 7.1 Old Business

a. President Dyment wanted to review District Goal #6. She noted that Mrs. Fay had brought to her attention that the goal does not read well. Mrs. Fay rewrote and President Dyment updated this version as well.

Moved by Tom Tarpley seconded by Phyllis Hagen, to accept the final revision of District Goal #6. In order to continue to deliver a well-rounded education, the district will review academic offerings, extracurricular activities, and sports, including their associated facilities, environment, support, and transportation requirements. (The motion carried 7-0.)

agency and vendors to seek reimbursement for monies paid by parents and students for the Trip; and WHEREAS, the District has negotiated a resolution with the travel agency, which would permit the District to provide reimbursements to parents and students with funds originally planned for the remaining costs to vendors for the Trip, which had not yet been remitted, and Extra classroom Funds, which are used for trips such as the Senior Class Trip; NOW, THEREFORE, BE IT RESOLVED that the Business Manager or her designee be, and hereby is, authorized and directed to distribute reimbursements to parents and students for the Trip; and be it further RESOLVED, that such reimbursements are only provided as authorized by this Resolution and that the District is not authorized to seek any further reimbursements or repayment on behalf of the parents and students who paid certain monies for the Trip; and be it further RESOLVED, that this resolution shall take effect immediately.

President Dyment stated that this resolution was to reimburse the parents and students for the Senior Trip that was scheduled for the 2019-20 school year. She noted that parents/students will receive a portion of expenses for the trip. Mr. Cipolla noted that the District is trying to do the best practice for accounting purposes. Mr. Markham stated that some parents purchased travel insurance and some did not and those that bought the insurance will receive as much as the travel insurance pays. The amount parents will receive is from \$225 - \$400. Mr. Tarpley asked what the parents' reaction was to hearing that there would be a reimbursement. Mr. Markham stated that most parents were happy to hear they were getting some money back. Mr. Cockram asked that if the student is off to college, who gets the money the parent or the child? Mr. Cipolla said the check would be made out to the parent. (The motion carried 7-0.)

Mr. Tarpley noted that he is happy to see that sports are back and up and running. He said it is great to see them practicing.

Mr. Hagen recommended that a card be sent to Mr. Catalano to congratulate him for his 30 years of service to the BOCES Board of Education.

BOARD MEMBER COMMENTARY

Mr. Cockram spoke about the Chautauqua County School Boards Association (CCSBA) meeting topic. It was on Cybersecurity. He noted that there are many scary individuals that try to get ahold of computer systems. They encrypt the data but if you get the locked information back, it is less than what was encrypted. Mr. Cockram said that it is most important to keep your hardware and software up to date. He said that when receiving emails, you should question yourself as to whether you should open the email. Mr. Cockram stated the ECMC computer information was stolen and it cost them \$10-20 million in consulting fees to get the data back from the back up. Barb mentioned that the presenter also noted that we should have multiple factor authentication as well. Mr. Cipolla noted that the software monitors emails. If a social security number is noticed, the email does not go out and will be held by the technology department for them to clear it. Mr. Cockram noted that it only takes one click of a key and the device used can wait for months until it has enough data to lock down the system.

President Dyment stated that a longtime employee has recently passed away. She was with the District for 30 some years. President Dyment will get a sympathy card.
