Elementary Principal's Report September 14, 2020

- Elementary Enrollment is 233
- We had a seamless transition into the school year. Everything is running smoothly amid the extra steps needed for the covid situation. The staff has worked well to get things accomplished. I appreciate them stepping up that first week of school when I was sick. We have an amazing staff.
- The FACS program donated a cricut to the elementary, so we have that technology available once we figure out how to utilize it.
- We got the theme shirts in for the school, and we will be wearing them on Mondays.
- Mrs. Mendoza received a \$1,160.00 grant from TCEC to replace some of the books which were never returned after the shut down. The Bank of Beaver City is sponsoring the AR 100 point club tee shirts. (\$420)
- I have to observe every probationary teacher during the first nine weeks, so since we have a shortened first quarter, I am working to get that in. We have to observe probationary teachers once during the first, second, and third nine weeks, and do an evaluation the fourth nine weeks. For career teachers, they are observed once during the first semester, once during the second semester, and get an evaluation the second semester.

Elementary Happenings:

- o The elementary football team is 1-0. They have only been able to play one game due to other teams not having enough players.
- o Dot Day is the 15th. Based on the book <u>The Dot:</u> we will write "Make your mark" in sidewalk chalk in front of the school, and classes will be encouraged to come make their dot/mark.
- o Teachers will begin their book study on the 15th. The book is When Kids Lead.
- O September 25th is Johnny Appleseed day, so we will have apple activities, and the staff will bring apple dishes to celebrate the day.
- o The lower elementary and EL are having a book drive. They are getting books for students to keep; each child will receive two books.
- o Ms. Ponce is doing a math activity with 5th/6th graders involving perimeter, area, and surface area. They will be figuring out materials needed to put a fence around the school (perimeter), replace flooring in certain classrooms (area), and painting a building (surface area).
- o Mrs. Lansden's class is doing a Reader's Theater mock trial of the Mean Troll vs. The Three Billy Goat's Gruff. This is based on the popular book and educates students on judges, lawyers, witnesses, etc. They are receiving parts and practicing; the Reader's Theater will be on September 18th.
