SUPERINTENDENT'S REPORT

- HVAC Update Miller Heating and Plumbing is beginning tomorrow to install the
 mini-split units that go on the roof of the building. The Airdale units have been
 ordered and will ship from the manufacturer on August 31, 2020. They plan to work
 after school is dismissed for the day to complete these installs. All rooms in which
 they are working will be sanitized before students enter the next day.
- Windows The windows are beginning to come off of the production line. They will be beginning soon to install these in both buildings. They will start with the front of the Elementary and the back of the building on the Third Floor at the High School. They will be working during the day and should take no more than a half a day to install a classroom.
- Blue Sky Academy (Remote Learning Options) We currently have around 50 students who are planning to complete their education this fall remotely through the ESC. We are asking these individuals to stay for this learning style at least a nine weeks before changing.
- Teachers and Custodians have worked very hard to get ready to open school during this time.
- The Elementary Cafeteria has been painted and is looking very nine.
