RESOLUTION NO. 21-11

A RESOLUTION OF THE BOARD OF EDUCATION OF UNIFIED SCHOOL DISTRICT NO. 224 ADOPTING THE "NEIGHBORHOOD REVITALIZATION PLAN FOR CLOUD COUNTY, KANSAS, 2021" AND AUTHORIZING ENTERING INTO AN INTERLOCAL AGREEMENT FOR THE ADMINISTRATION OF THAT PLAN.

BE IT RESOLVED BY THE BOARD OF EDUCATION:

Section 1. Finding. The Board has reviewed the "Neighborhood Revitalization Plan for Cloud County, Kansas, 2021" as adopted by the Cloud County Board of County Commissioners (hereafter the "Plan"), and finds and determines that the property within the District which lies within the Neighborhood Revitalization District, as set out in Exhibit A to the Plan, meets the definition of "neighborhood revitalization area" in K.S.A. 12-17,115(c).

<u>Section 2</u>. <u>Plan Adoption</u>. Following a properly noticed public hearing, as required by K.S.A. 12-17,117, and consideration of comments from the public and staff, the Plan is hereby adopted and incorporated by reference as if fully set out herein.

<u>Section 3. Interlocal Agreement.</u> The President is authorized, on behalf of the Board, to enter into an interlocal agreement with Cloud County, USD Nos. 333, 334, Cloud County Community College, and the cities of Aurora, Clyde, Concordia, Glasco, Jamestown and Miltonvale, as necessary to implement the Plan, as provided for in K.S.A. 12-17,119.

Section 4. Effective Date. This resolution shall take effect and be in force as of August 17 , 2020.
