EXPLANATION:	The Alpine Union School District and the California School Employees Association and It's Chapter 607 reached a Tentative Agreement on July 9, 2020. This agreement included changes to Articles 5 and 7 that are listed on the accompanying Tentative Agreement. CSEA notified the District on September 14, 2020, that it ratified the Tentative Agreement with its membership and received the required 610 approval. The required AB 1200 Disclosure (Government Code 3547.5) has been submitted to the San Diego County Office of Education.

PROPOSED TENTATIVE AGREEMENT BY AND BETWEEN THE CALIFORNIA SCHOOL EMPLOYEES ASSOCIATION AND ITS CHAPTER 607 AND

ALPINE UNION SCHOOL DISTRICT

The Alpine Union School District ("District") and the California School Employees Association and its Chapter #607 ("CSEA") enter into this tentative agreement to implement Article 5.0 of the collective bargaining agreement.

The District and Alpine Teachers Association ("ATA") recently concluded reopener negotiations and ratified a tentative agreement that increased the total compensation of that bargaining unit by 2.29%. In addition, the District and ATA agreed to revise the certificated salary schedule for the express purpose of increasing the compensation only to lower paid steps, at an additional cost to the District of 0.57%. Finally, the District and ATA agreed to increase the health and welfare benefits cap to \$10,996.

Pursuant to Article 5.0 of the collective bargaining agreement, the parties agree that the following constitutes equity and parity to classified unit members.

Article 5, Wages

The 2019-20 salary schedule shall be increased by 2.29% effective July 1, 2019. In addition, the salary schedule will be increased for four classifications (Delivery Services Transporter, Administrative Assistant - Programs, HR Technician, and Instructional Assistant) by a total equivalent cost to the District of 0.57%, effective July 1, 2020, as set forth in the attached document.

Article 7, Health and Benefits

Effective January 1, 2020, the maximum annual District expenditure for medical benefits, dental insurance, vision, life insurance and disability insurance, shall be \$10,996 per eligible unit member, regardless of level of benefits selected (single, employee plus one or family) or benefit plan selected. Any additional costs over and above the "floating cap" shall be deducted from the employee's monthly paycheck.

By accepting this increase in compensation, CSEA agrees that this fully resolves the parties' current successor agreement negotiations as those relate to any increases in unit member compensation, and CSEA will not propose any additional increases in unit member

compensation as part of the parties' current successor agreement negotiations. This does not waive CSEA's right to negotiate any other subjects in the parties' current successor agreement negotiations.

Due to the fact that the District is not deficit spending the District did not need to make any cuts or reductions to any specific program, either instructional or non-instructional to accommodate these settlements. A specific impact of the reclassification of the four job classification is that it helps achieve our goal of moving closer to having our salaries meet the median average salary in the county. This allowed us retain key staff in hard to fill positions.

Beyond the scope of this question are the non-specific impacts of this salary increase. Of which is an increase in staff morale, improved recruitment and retention of staff, and the opportunity cost of having fewer funds in the future for the purchase of instructional and non-instructional supplies and services.

What contingency language is included in the proposed agreement? Include D. specific areas identified for reopeners, applicable fiscal years, and specific contingency language.

Applicable fiscal years:

The general salary increase applies to the salary schedule as of 19/20 and remains in place until replaced/changed in another agreement.

The reclass of the four job classifications are effective for the 20/21 fiscal and remain in place until changed in another agreement.

The increase in the H&W cap is effective Jan 1st, 2020 and remains in place until replaced/changed in another agreement.

The additional pay of \$500 for the custodians is effective for the 20/21 fiscal year only.

Contingency language.:

In the event any District school or worksite must be closed due to COVID-19, classified unit members will not suffer the loss of any pay or benefits relative to their regular schedules for the period of closure, provided that the District does not experience a decline in state funding during the period of closure.
