

Oakdale Reopening Plan

1. Staff

- a. **Teachers:** Monitor health prior to coming to work by taking temperature. Wash hands prior to leaving home. Self Monitor when arriving at school by checking temperature with the thermal scanner in the staff room. Wash hands when arriving at school. Wear a mask or face shield when in common areas, with other staff, and with students. Maintain social distancing of 6 feet or more. Teachers must be in their classroom to greet students no later than 8:00 AM.
- b. **Aides:** Teachers: Monitor health prior to coming to work by taking their temperature. Wash hands prior to leaving home. Self Monitor when arriving at school by checking temperature with the thermal scanner in the staff room. Wash hands when arriving at school. Wear a mask or face shield when in common areas, with other staff, and with students. Maintain social distancing of 6 feet or more.
- c. **Kitchen staff:** Teachers: Monitor health prior to coming to work by taking temperature. Wash hands prior to leaving home. Self Monitor when arriving at school by checking temperature with the thermal scanner in the staff room. Wash hands when arriving at school. Wear a mask or face shield when in common areas, with other staff, and with students. Maintain social distancing of 6 feet or more.
- d. All Staff, Must sign in and sign out for the purpose of contact tracing, if necessary.

2. Visitors

- a. **Parents:** Must report to the office to sign in. Must wear a mask on campus. Must notify school 24 hours prior if wanting to observe in the classroom.
- b. **Other:** Must report to the office to sign in. Must wear a mask on campus.

3. **Students entering the site:** Prior to leaving the home, Parents should check students temperature to ensure it is below 100.4. Students need to stay home if they have a temperature of 100.4 degrees or higher. Students should also wash their hands prior to leaving the house.

- a. **On time:** All Students are required to wear a mask when on campus. All Students will report directly to the cafeteria when they first arrive on campus to have their temperature taken on the thermal scanner. All students will need to use the provided hand sanitizer prior to the temperature check. Students with breathing or health issues may opt to wear a face shield. Students will grab their breakfast, and report directly to the classroom. The play areas are closed prior to school day starting.
 - b. **Tardy Students:** Students who show up to school late, must report to the office to have their temperatures taken with the Thermal scanner and to sign in. Students must sanitize their hands prior to having their Students will need to wash their hands prior to entering the classroom.
 - c. **With fever/covid symptoms:** Students who arrive at school with a fever of 100.4 degrees or higher, or show other COVID Symptoms will be placed in an isolation room with a staff member. Parents will be called immediately, and the student will need to be picked up right away.
4. **Classrooms:** Class sizes will be limited to ½ of the total class size to help provide more room for social distancing. Students are assigned their individual Chromebooks. Students may not share materials. Students will be seated as far apart as possible, and clear dividers will be provided to help separate students.
5. **Recess:** Recess will be by grade level to limit the number of students in one area. All playgrounds will be utilized to help limit the number of students in one area. Students must maintain social distancing and wear their mask. Students will not be able to share equipment.
6. **Lunch:** Lunch schedules will be by grade level to limit the number of students in an area. All playgrounds will be utilized to help limit the number of students in one area. Students must maintain social distancing and wear their mask in 3rd through 5th grade. Students will not be able to share equipment.
7. **Common areas:**
 - a. **Hallways:** Where possible, directional arrows will be placed in the hallway to denote a common direction to limit close contact with others walking the opposite direction.
 - b. **Restrooms:** use multiple restrooms and limit the number of students in the restroom at one time.
