BackPack Program Partner Guidelines 2020-2021

Mission

The mission of the Weekend BackPack Food for Kids Program (or "BackPack Program") is to help solve child hunger in America by providing nutritious and easy to prepare food to children to take home on weekends and school vacations when other resources are not available.

Traditional backpacks include 16 items: 4 entrees, 4 fruit cups, 2 cereals, 2 juices, 2 milks, and 2 snacks. Enough food is provided for 6 simple meals and 2 snacks for one child over the weekend. All items are shelf stable.

Enrollment

This program is new to our district. To enroll your student(s) in the BackPack Program — A new application is required to be completed <u>every</u> year. This program is available for <u>every</u> student in our district. Please return the attached application by <u>Friday</u>, <u>October 23</u>. If you do not return the form it will be assumed that you do not wish to enroll in this program.

Bags will be distributed weekly on Thursday.
