

Health Requirements:

I. Kindergarten, Pre-Kindergarten, and Early Childhood Students -All students entering the mentioned grades for the first time must present proof of a current physical examination that was completed after the first day of the previous school year and immunization record by September 15. Pre-K, ECE and K must provide proof of one dose of pneumococcal conjugate vaccine if the student is under five years old. Kindergarten students shall show proof of 2 doses of varicella vaccine, the first dose on or after the first birthday and the second dose no less than 28 days after the first dose, or proof of prior varicella disease documented by a physician. In addition to these requirements, Kindergarten students are required to have a current dental examination on file in the school office that was completed in 18 months prior to the May 15 due date. Kindergarten students are required to have an eye examination that was completed in one year prior to September 15 due date. Physical and up-to-date vaccination form must be turned in by September 15 or your student will be excluded.

II. Second Grade Students- Current dental exam on file by May 15 which was completed in the 18 months prior to the due date.

III. Sixth Grade Students-3 doses of Hepatitis B, 2 doses of varicella and 1 dose of meningococcal are mandated vaccinations for sixth grade. Most children are given Hepatitis B immunizations as infants. Please verify with the healthcare provider before restarting the series. Sixth graders shall show proof of 2 doses of varicella vaccine, the first dose on or after the first birthday and the second dose no less than 28 days after the first dose, or proof of prior varicella disease documented by a physician. Sixth Grade students are also required to present a school physical before September 15 that was completed after the first day of the previous school year, a sports physical will not be accepted. 6th graders must turn in state dental exam form by May 15 which was completed in the 18 months prior to the due date. Physical and up to date vaccination form must be turned in by September 15 or your student will be excluded.

IV. Sixth Through Twelfth Grade Students -All students in sixth, seventh, eighth, ninth, tenth, eleventh and twelfth grade must provide proof of Tdap immunization. If these records are not presented by September 15, your child will be excluded from school.

V. Ninth Grade Students-All students in ninth grade must provide proof of a school physical completed after the first day of the previous school year and an up-to-date immunization record by September 15. Proof of 2 doses of varicella vaccine, the first dose on or after the first birthday and the second dose no less than 28 days after the first dose, or proof of prior varicella disease must be documented by a physician. A sports physical will not be accepted. All 9th grade students must turn in state dental exam form by May 15 which was completed in the 18 months prior to the due date. Physical and up-to-date vaccination record must be turned in by September 15 or your student will be excluded from school.

VI. 12th Grade Students-Meningococcal vaccine given after 16 years of age is required for seniors. Vaccination form must be turned in by September 15 or your student will be excluded from school.

VII. All students entering Olympia Schools with it being the first time attending an Illinois school are required to present a current school physical, not sports physical, obtained in the state of Illinois and immunization record within thirty days of entering school. A dental exam and vision exam are also recommended. Physical examinations, immunization records, dental and eye examinations presented to the school must be current, within one calendar year of the registration date. If school physical or up-to-date vaccination records have not been presented by thirty days after entering school, your child will be excluded from school.
