The staff member is self-quarantining at home, has displayed no symptoms of the virus and has not tested positive for the virus. Due to privacy laws, we cannot disclose further information about the employee. Whenever a person has recently had close contact with a person with COVID-19, they must quarantine and may not return until they meet the CDC's criteria for return to work—which currently provides that the individual should stay home for 14 days after his/her last contact with the person who has COVID-19.

The local health department has been notified of this situation. Based on guidance from the health department and other agencies, **Valley Elementary School and Valley Middle School** has been deeply sanitized and it has not been closed. District employees and students should continue to follow CDC guidelines and recommendations, and should continue to practice social distancing.
