Called to Order. The meeting was called to order in the Library at 6:30 p.m. by President Wohlers.

Consent Agenda. Motion was made by Director Neill and second by Director Thomas to consent agenda includes approval of the agenda, board minutes from September 9th and September 14th, approval of monthly bills, and approval of financial reports. No objections. Motion carried. 5-0

Resolution to Consider Continued Participation in the Instructional Support Program and to Schedule a Public Hearing.

The Board of Directors of the West Harrison Community School District, in the Counties of Harrison and Monona State of Iowa, met in regular session, in the West Harrison CSD High School Library at 410 Pine Street, Mondamin, IA at 6:30pm. Consideration of Compensation. Motion was made by Director Neill and second by Director Thomas to compensate Tonya Radil for assisting daily in the kitchen. This compensation will be \$10.00 a day not to pay retroactive. Compensation will begin October 14, 2020. No Objection. Motion carries. 5-0

Consideration of Van Purchase. Motion was made by Director Kuhlman and second by Director Thomas to purchase a twelve passenger van for activity use due to lack of sub bus drivers. Discussion. No objections. Motion carried. 5-0

Consideration of Rotary Broom and Bristle Attachment Purchase. Motion was made by Director Neill and second by Director Hamer to approve purchases. Discussion. No objections. Motion carried. 5-0

Consideration of Replacement of Six Heating Units. Motion was made by Director Hamer and second by Director Neill to approve the purchase of heating units. Discussion. No objections. Motion carried. 5-0
