The school will work with Yerger Middle School and Hope Academy of Public Service to help provide a smooth transition from one school to the next by raising parent awareness of procedures and related activities. The school will host special orientation programs for parents and students to help with the transition. Parents will have the opportunity to meet the new teachers at the end of the school year. The schools will work together to make handbooks similar to aide in the transition from one grade to the next.
