


## There are 36 school districts that receive more state funding per student, than Waynesboro spends per student!

This is a generational issue affecting our community. How many generations should receive less resources than their peers?




# **Revenue & Expenditures = \$60.23M**

### **Fund Balances (Reserves)**

- Cash Flow to meet payroll and expenditures at the beginning of the fiscal year
- Emergency repairs
- Unplanned increases in enrollment of regular and special education students
- Downturns in the economy affecting earned income and occupation tax revenues
- Building repairs, renovation or construction
- Reductions in funding from Federal and/or State resources
- Delays in Federal and/or State resources
- Bond rating companies require higher rates of interest with no or little fund balance.
- WASD's unassigned fund balance would make payroll for approximately 26 days – then the District would be out of funds.



#### **State Funding Changes to School Districts**

Cyber Charter Reimbursement of 30% Plancon for Building Construction No longer exists for new projects

Transportation is Flat Funded to 2015 levels – runs out in March Gambling Proceeds Flat for Homestead for over 10 years



## **Public School Employee Retirement System**

 School District contributes 34.29% in 2019-20 – slightly more than half is reimbursed by PA

Net Liability = \$48,004,965,000


PSERS investments as of 6/30/2018




# **Pension Cost Comparison**

- 2009-2010 Pension Cost = \$1,121,000
- 2019-2020 Pension Cost = \$8,380,000
- Total Increase of \$7,259,000
- WASD Share at 41% is approx \$3,436,000

BEF WASD PSERS




SEF WASD Special Ed Cost
