

Budget Committee met 6 times from September 2022 through March 2023



WAYNESBORO AREA SCHOOL DISTRICT Acronyms & Descriptions

Acronym	Detail	Description	
Abraxas	Nonprofit provider of youth and family services in Franklin County.	Provides secure retention facility and all education expenses pass through WASD as the local education agency.	
ADM	Average Daily Membership	Used to calculate attendance/membership of students in a school district. Calculated by dividing the aggregate days membership for all children on active rolls by the number of days the school district is in session.	
BEF	Basic Education Funding	The state's method of providing a funding stream to PA school districts. The BEF funding formula contains both fixed (hold harmless) and variable (formula) sections.	
Career Tech	Franklin County Career & Technology Center	Located south of Chambersburg along Rt. 11, it is a jointly-owned facility by the Franklin County school districts providing tech and career training for our students. 24 programs including dental assisting, agricultural mechanics, cosmetology, welding, etc.	
IDEA	Individuals with Disabilities Education Act	Federal law mandating free appropriate public education to eligible children with disabilities.	
LECI	Local Effort Capacity Index	The state's measure of the total local tax effort placed on each household at the median household income level for a school district.	
MVAR	Market Value Aid Ratio	A measurement of local wealth using property values and income on a per student basis. A lower number indicates wealth. A higher number indicates poverty or economic disadvantaged. WASD=0.63 Average PA school district = 0.55	
Mill	Used for property taxes it is an abbreviation for $1/1000^{\text{th}}$.	One mill is equal to \$1 of property tax for every \$1,000 in assessed value.	
PRRI	Private Residential Rehabilitative Institutions	Abraxas is an example as well as other placements across PA	
PSERS	Public School Employees' Retirement System	Mandated retirement program for PA school employees and school districts.	
SEF	Special Education Funding	The state's method of providing a funding stream to PA school districts for special education services.	



WAYNESBORO AREA SCHOOL DISTRICT 2023-24 Proposed Final Budget

Revenues \$77.9 million **Expenditures** \$79.3 million

Deficit \$1.4 million

Reflects all committee approved educational opportunities for our students

Anticipates Using ESSER \$
ESSER III = \$6.3 million
(\$4.3M for capital projects)

Deficit can be addressed in several manners



What is driving the expenditures year-over-year?

Salaries = 4.6% or \$1.3 million

Transportation = 8.2% or \$267,000

Medical Insurance = 16.8% or \$950,000

Career Tech = 11.1% or \$106,000

Social Security = 4.7% or \$98,000

Abraxas / PRRI = 5.6% or \$236,000

Worker's Comp = 23.6% or \$38,000


Capital Projects = 55.1% or \$1.6 million

Pre-K Counts Grant = \$14.3% or \$170,000

We are continuing to review expenditure savings opportunities in the budget. Some programs are grant-based or revenue neutral (i.e. Abraxas, Pre-K counts & capital projects)

Major Expenses – Uncontrollable as % of Total Budget


Special Education \$10.1 million / 12.74%

Cyber Charter Schools \$3.6 million / 4.5%

<u>Pension</u> \$9.7 million / 12.2%

Medical Insurance \$6.6 million / 8.3%

Transportation \$3.5 million / 4.4%



Revenue – Increasing Opportunities

Current Real Estate = 1.4% or \$370,000

Basic Ed Funding = 11.9% or \$1.8 million

Earned Income Tax = 8.6% or \$300,000

Special Ed Funding = 10.0% or 273,000

Investment Earnings = 700% or \$175,000

Pre-K Counts = 14.3% or \$170,000

IDEA Pass Thru = 18.4% or \$124,000

State funding could change based on final approved budget. Does not include an increase in current real estate mill rate. Does not assume a major economic change in 2023-24.



WAYNESBORO AREA SCHOOL DISTRICT How to Balance the Budget

District has several options

District's current spending is already in bottom 1-2% of all PA schools

Fair Funding by State would increase student opportunities & provide taxpayer relief

Mill rate could be increased within the inflationary index
(Act 1)


Unassigned Fund Balance (Savings) could be utilized


Additional program or education reductions


Could be a mix or combination of the above options






Basic Education Funding Formula



Basic Education Funding Formula

The formulas are actually more complex...the weights have weights.

What did all of those metrics mean?

For every \$100,000,000 the state adds to the BEF



WASD receives \$215,812 (at current share)



Equates to 0.28% of our total revenues.



WAYNESBORO AREA SCHOOL DISTRICT Funding Comparison

If \$100 million of BEF provides \$215,812 in revenue, how does that compare to our expenses?

WASD receives \$215,812 (at current share)



Equates to 0.28% of our total revenues.

WAYNESBORO AREA SCHOOL DISTRICT Summary

School Board has proactively approved budgets that increase student opportunities

Salary and negotiation's actions by the Board have increased competitiveness with teacher salaries

Since Act 1 Index went into effect, WASD's taxes are 25.4 mills or 19.4% *lower* than permitted

WASD has the least amount of property to tax per student in Franklin Cty

Market Value Aid Ratio increased to 0.63 – highest in Franklin County

Basic Education Funding is below average for PA school districts

WASD would have to spend \$19 million per year to be an "average" PA school district.
