

# TAXES PERTAINING TO WASD RESIDENTS

Waynesboro Area School District has a few taxes that may or may not apply to those residing within the school district's boundaries. To determine if these taxes apply to you, please contact your tax collector. Their contact information is provided below.

## 1. Real Estate Tax - School District

- Annual tax that homeowners must pay on the assessed value of their home.
- This bill will arrive on or around July 1 of each year. The bill is due by October 31st of each year. A 2% discount is applied if the bill is paid by August 31st.
- The County determines the assessed value of each property..

## 2. Real Estate Tax - County & Municipality

- Annual tax that homeowners must pay on the assessed value of their home.
- This bill will arrive on or around March 1 of each year. The bill is due by June 30th. A 2% discount is applied if the bill is paid by April 30th.

## 3. State Income Tax

- A 3.07% withholding tax from employee wages paid to the Commonwealth of Pennsylvania. Out of state employers may or may not automatically withhold this tax from paychecks. Please discuss this matter with your employer. If your employer does not automatically withhold this tax, quarterly payments will need to be made to avoid penalties.

## 4. Local Income Tax - School District & Municipality

- A 1.0% withholding tax from employee wages split between the school district and the municipality. Individuals who live in Chambersburg or Shippensburg pay different rates.
- Out of state employers may or may not automatically withhold this tax from paychecks. Please discuss this matter with your employer. If your employer does not automatically withhold, quarterly payments will need to be made to avoid penalties. ## 5. Local Services Tax

- \$52.00 Annual Tax
- Applies to individuals employed in the community. Your employer will typically withhold that tax from your wages.

## 6. Per Capita Tax

- \$10.00 Annual Tax
- Applies to only Mont Alto Borough and Quincy Township residents who are 18 years of age or older.
- **Permanent Exonerations:** usually elderly, permanently handicapped, nursing home residents, dementia, alzheimers, mentally disabled, etc.
- **Other Exonerations Reasons:** under age, duplication, deceased, financially unable to pay, military, non-resident (outside of WASD), student, unknown, and non-resident within District (taxpayer moves to another township within WASD).
