Dear RSU 57 Community,

Thank you all for your patience and understanding as we navigate these challenging times together. Given the progression of events and subsequent communications, we thought it would be helpful to offer a district-wide update as it relates to operations at each of our schools at the time of this communication.

### **Massabesic Middle School**

As of today: 8 confirmed positive, **there has been no change since 10/4/20.**

The school building has been thoroughly cleaned, per CDC guidelines, following school closure. Staff returned to work at the school building on Monday, October 5th. Those staff who were in quarantine have now completed quarantine requirements and have returned to work in the school building. The Maine CDC has determined that the Massabesic Middle School outbreak designation has been lifted as of today, 10/30/20. Students attending school in person will return to school on Wednesday, 11/04/20. The middle school Administration has informed their parents/students of the return to in person learning date.

### **Massabesic High School**

As of today: 1 probable positive (now determined to be negative)

Staff continues to work from the school building, those staff who were in quarantine due to the 1 probable positive returned to work from the school on Tuesday, October 13th. Those students attending school in person also returned to school Tuesday, October 13th. **There has been no change since 10/13/20.**

### **Waterboro Elementary School**

As of today: 2 confirmed positive, **there has been no change since 10/2/20.** At this time all staff and students associated with the 2 positive cases have completed their quarantine requirements and have returned to school.

### **Lyman Elementary School**

As of today: No reported cases

At this time there are no changes to programming or operations of the school.

**LINE Elementary School**

As of today: No reported cases
