

## College Exploration Summer Seminar June 20-22, 2023

This three-day long summer seminar is designed to expose high school students to a variety of college campuses and assist them in the process of developing their own college search criteria. The program will include a series of three day trips to local colleges and universities. Students will take guided tours and attend information sessions at each campus. They will learn how to determine if a school may be a good match for their individual interests, goals, and needs. Admission requirements and the application process will be discussed, as well. We will tour public and private colleges that range in selectivity, size, cost, and setting.

This seminar is open to students entering grades 10-12.
